RESULT NOTICE NO- 608
HEAD CONSTABLE (POST CODE 43/2013)
TRANSPORT DEPARTMENT, GNCT OF DELHI

The Board vide Advt. No. 03/13 had advertised 99 vacancies (UR-50, OBC-27, SC-15 & ST- 07 including 10 EXSM) for the post of Head Constable in Transport Department GNCT of Delhi under Post Code 43/13. The closing date of application /cut off date was 18.10.2013. Board had conducted written test for this post on 28.09.2014. The result of Tier-I examination was processed and candidates were shortlisted vide Notice No. 418 dated 24.07.2015 for physical endurance test (PET). Thereafter Physical Endurance Test was conducted by DSSSB from 15.06.2016 to 16.06.2016. During the conduct of PET during 15.06.2016 to 16.06.2016 in addition to other aspects of the RRs a race event was also conducted. Thereafter, the result for the post Head Constable under post code 43/13 was processed and result declared in r/o 70 candidates (UR-32, OBC-14, SC-11, ST-04 & EXSM-09) vide result notice No. 523 dated 01.08.2016. Aggrieved by the decision of the Board to conduct the Race event some candidates filed an application before Ld. CAT vide OA No. 2162/16, MA 2027/16. Both the OA & MA were allowed by Hon'ble CAT & it was directed vide order dated 01.07.2016 that the respondent i.e. DSSSB shall not declare the result of the said examination. Therefore, in Compliance of the order of Hon'ble CAT in OA No. 2162/2016, MA-2027/2016 titled Ashwani Rana v/s GNCT & Ors. the above said Result Notice No. 523 dated 01.08.2016 (Provisional result) for the post of Head Constable, Post Code 43/13 issued by the DSSSB was withdrawn vide Public Notice No. 525 dated 23.08.2016 due to Administrative/judicial reason in pursuance to CAT order dated 01/07/2016 in OA No. 2162/2016, MA. No. 2027/2016

Further in OA No 2162/2016, MA-3192/2017 Hon'ble CAT passed the order, operative part of which is given as under:-

"Thus, we come to the conclusion that the action of the respondent DSSSB in prescribing a race event for judging suitability of the candidates for the post in question was against law and beyond their jurisdiction. We also come to the conclusion that the applicants by mere participation in the selection process were not stopped from questioning the same since the action of the respondents was not sustainable under law, we, therefore, allow this OA and direct the respondents to prepare the merit list of the aforesaid selection by ignoring the race event. If the applicants are otherwise eligible and find a place in the merit list, they shall be considered for appointment along with other. No. costs"

The matter was discussed in the Board in light of the directions passed by the Hon'ble CAT in O.A. No.2162/2016 and the Board passed the following resolution:-

Resolution No. Exam-II/2017/19:- The above agenda with regard to selection process for the post of Head Constable (Post Code 43/13) was discussed in the light of the directions passed by Hon'ble CAT in OA No. 2162/2016 titled "Ashwani Rana & Others Vs GNCTD & Others". It was resolved that the Board should go strictly by the RRs prescribed for the said post and therefore, should recommend the candidates on the basis of written examination and the Physical Endurance Test as per RRs which would also be compliance of Hon'ble CAT order. The aspect of physical standard/sound health/medial fitness as given in RRs, should ensured by the Transport Department through appropriate examination of the candidates selected.

In view of the decision taken by the Board and in compliance of order of Hon'ble CAT in O.A. No 2162/2016 titled Ashwani Rana, the result for the post of Head Constable under post code 43/13 has been prepared taken into account marks of the written test and the PET (excluding race event) conducted by DSSSB. Height of the candidates had been measured as per clause 7(III) and Chest was measured as per clause 7 (IV) of the RRs. Race event was also conducted for the 400 shortlisted candidates, however now while preparing the result the race event has not been taken into account while preparing the result.

On the basis of the marks scored by the candidates in written test & Qualified in Physical measurement and after preliminary scrutiny as per the provisions of the statutory Recruitment Rules for the post and the terms and conditions of the advertisement, the following candidates (category wise) are provisionally selected to the post of Head Constable (Post Code 43/13) subject to their fulfilling all other conditions of eligibility and also verification of correctness of the information furnished by the candidates in their online application forms:-

The selection of above 71 candidates (UR-38, OBC-14, SC-09, ST-04, UREXSM-04 & OBCEXSM-02)) is based on submission of photocopy of documents related to age, qualification & caste certificate etc. & original of same have not been seen/verified by DSSSB shall further be subject to fulfilment of all the eligibility conditions as prescribed and the terms and condition of advertisement for the said post. The provisionally selection is also subject to verification of their identity of the candidate w.r.t. their photographs, signatures/handwriting etc.

The candidature of the candidates are liable to be cancelled by the User Department also, in case the candidate is found not to be fulfilling the eligibility

conditions or due to any other genuine reason. **The Competent Authority of User Department shall issue the appointment letters to the candidates only after satisfying themselves of their eligibility as laid down in the Recruitment Rules and on verification of the correctness of the information/documents/caste certificate/Driving Licence for LMV furnished by the candidates.**

The candidates who have availed the benefit of the reservation at the time of shortlisting of candidates on the basis of written examination have been considered for final appointment in their respective category only.

The User department shall also check the eligibility of the candidates availing benefit of reservation. Further, wherever applicable, User Department i.e. Transport Department, GNCT of Delhi shall verify the genuineness of the caste certificate furnished by the candidate prior to issuing offer of appointment to the candidates. The Competent Authority of the User Department shall arrange to verify the correctness of the information/ documents as furnished in the application forms and documents submitted by the candidate and cross verify the same from the original documents. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates and essential qualification regarding successful completion of training for the post before issuing offer of appointment to the candidates.

Further, the recognition of the Board/Authority/Institution from which the certificates/driving licence to drive Light Vehicles etc. have been issued and submitted by the candidates should also be verified thoroughly by the Transport Department and also verified date of issue & validity of the driving licence as per the RRs.

Transport Department shall also get the SC/ST/OBC certificates verified from the issuing authority. Further, in case of the OBC candidates, it may also be verified that the candidate does not belong to creamy layer of the schedule of Govt. Of India, DOPT O.M. No. 36012/22/93-Estt.(SCT) dated 08.09.1993 O.M. No. 36033/3/2004-Estt. (Res) dated 09.03.2004 and O.M. No. 36033/3/2004-Estt. (Res) dated 14.08.2008.

Mere inclusion of the name of the candidate in the result notice does not confer any right upon the candidate over the post unless the User Department is satisfied after such inquiry as may be considered necessary that the candidate is suitable in all respects for appointment to the post.



Note : OBC (Outsider) candidates have been treated as UR candidates.

While every care has been taken in preparing the result and shortlisting of candidates, DSSSB reserves the right to rectify errors and omissions, if any detected at any stage.

Further, shortlisting of 17 ST Candidates on the basis of written examination conducted on 28.09.2014 for appearing in physical endurance test (**physical measurement**) for the post of Head Constable, (post code 43/13) in Transport Department, GOVT OF NCT OF DELHI for filling up the remaining vacancies in ST category.
