RESULT NOTICE NO- 609 SPECIAL EDUCATION TEACHER IN DTE. OF EDUCATION, GNCT OF DELHI UNDER POST CODE 146/14

- 1. The DSSSB vide its advertisement No 01/2014 dated 20.01.2014 had advertised 669 vacancies (UR-242, OBC-237, SC-124 & ST-66) including PH/OH-10 & VH-14) for the post of Special Education Teacher in the pay scale of Rs 9300-34800 + Grade Pay Rs 4600/- in the Dte. of Education, GNCT of Delhi under Post code 146/14. The Board conducted written examination for recruitment to this post on 19.10.2014. On the basis of marks secured by the candidate in the examination and after preliminary scrutiny as per the provisions of the statutory Recruitment Rules for the post and the terms and conditions of the advertisement, the result for provisional selection of candidate was declared by DSSSB on 03/02/2016, 07.02.2016 and 09.05.2017.
- 2. The candidate Deepak Kumar Tiwari having roll no. 17001832 was rejected vide rejection notice no. 436 dated 03.02.2016 due to the reason "Qualification not as per R.R". Subsequently clarification was received from Dy. Director Education (IEDSS) vide letter No. F.167/DDE(IEDSS)/ADMN.Cell/2016-17/915 dated 14.03.2017 that the qualification required for the post of Special Education Teacher (Post Code 146/14) may be read as "Graduate with B.Ed (Gen) with one year Diploma in Special Education & CTET. In view of the clarification received as mentioned above read with the Recruitment Rules, preliminary scrutiny of copies of documents submitted by the candidate and subject to fulfilment of all other conditions of eligibility and also correctness of the information furnished by the candidate in his online application form, the following candidate is provisionally selected for the post of Special Education Teacher under post code 146/14:-

3. The selection of the above 01 candidate (UR-01) shall be further subject to thorough verification of his candidature by the User Department. The candidature is liable to be cancelled by the User Department, in case, candidate is found not fulfilling all the eligibility conditions of the Recruitment Rules for the posts or for any other genuine reason. The decision of the User Department regarding the eligibility of the candidate shall be final and binding on the candidate.

Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates and essential qualification regarding successful completion of training for the post before finally appointing the candidate before issuance of offer of appointment.
- 5. Mere inclusion of the name of the candidate in the result notice does not confer any right upon the candidate over the post unless the user department is satisfied after such inquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the post.
- 6. While every care has been taken in preparing the result, DSSSB reserves the right to rectify errors and omissions, if any detected at any stage.
