UNDER POST CODE 04/2014**

1. The DSSSB vide its advertisement number 01/2014 with closing date 27/02/2014, had advertised 02 vacancies (UR-01, OBC-01, including OH-01) for the post of Physiotherapist in MCDs under **Post code 04/2014** in the pay scale of Rs. 9300-34800/ having Grade Pay of 4200/- (Pre revised). The Board had conducted screening test on 25.05.2014 for shortlisting the candidates to appear in Interview. Subsequently, Interview of the Shortlisted candidates was held on 10.09.2014 and 20.02.2017. On the basis of the marks scored by the candidates in Academic qualification Assessment and Interview, merit list has been prepared.

2. The result for the post was earlier withheld as WPC bearing number 606/16 in the matter of DSSSB vs Jitender Munjal was pending in the Hon'ble High Court of Delhi against the Ld CAT order dated 17.12.2014 in OA No 3142/14 in the matter of Jitender Munjal vs DSSSB. Further Hon'ble High Court vide its order dated 12.02.2018 has set aside the Ld CAT order dated 17.12.2014 in OA No 3142/14 in the matter of Jitender Munjal vs DSSSB.

3. Marks of all the candidates who have appeared in the interview have been uploaded on Board's website. Candidates can view their marks by logging into their account in OARS module on [www.dssbonline.nic.in](http://www.dssbonline.nic.in).

4. On the basis of the merit list and after preliminary scrutiny of the candidature as per the provisions of the statutory Recruitment Rules for the posts and the terms and conditions of the advertisement, the following candidates are provisionally selected to the post of Physiotherapist under **Post code 04/2014**:

7. The selection to the only vacancy of UR category has been filled by horizontal reservation by OH candidate.

8. The selection of the above 2 candidates shall be further subject to thorough verification of the candidature of the candidates by the User Department. The candidature of the candidates is liable to be cancelled by the User Department, in case candidate is found not fulfilling all the eligibility conditions of the Recruitment Rules of the posts or for any other genuine reason. The decision of the User Department/appointing authority regarding the eligibility of the candidate including the essential qualification shall be final and binding on the candidate.

9. The candidate who have availed the benefit of the reservation at the time of shortlisting of candidates on the basis of Tier I written examination have been considered for final appointment in their respective category only. The User department shall also check the eligibility of the reservation benefit, if any. Further, if applicable User Department shall verify the genuineness of the caste certificate furnished by the candidate prior to issuing offer of appointment to the candidates. The Competent Authority of the User Department shall arrange to verify the correctness of the information/documents as furnished in the application forms vis-à-vis the original documents. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates before finally appointing the candidates.

10. Mere inclusion of the name of the candidate in the result notice does not confer any right upon the candidate over the post unless the appointing authority is satisfied after such inquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the post.

**11. While every care has been taken in preparing the result, DSSSB reserves the right to rectify errors and omissions, if any detected at any stage.**
