**ASSISTANT LAW OFFICER/LABOUR COUNSEL  
IN MUNICIPAL CORPORATIONS OF DELHI  
UNDER POST CODE 47/2013**

1. The DSSSB vide its advertisement No 03/2013 with closing date 18.10.2013, had advertised 06 vacancies (UR-5, OBC-1 including PH(OH)-1) for the post of Assistant Law Officer/Labour Counsel in Municipal Corporations of Delhi under **Post code 47/2013** in the pay scale of Rs. 9300-34800/- having Grade Pay of 4800/- (Pre- revised). The Board had conducted Tier I examination on 26.04.2015. The Tier II examination was conducted on 26.06.2016.

2. As per the scheme of examination in Advertisement No 03/13, the mode of selection for the postcode 47/13 was notified as Three Tier examination (G). However in view of Board's Notice dated 02.06.2017 the interview process in the selection has been scrapped and the selection process in respect of posts having three tier examination scheme has been converted into two-tier examination scheme.

3. The marks of Tier-II examination was declared vide Notice No. 566 dated 02.11.2017 and e-dossiers from the shortlisted candidates have been obtained. On the basis of the merit list of Tier- II examination and after preliminary scrutiny of the candidature as per the provisions of the statutory Recruitment Rules for the post and the terms & conditions of the advertisement, the following candidates are provisionally selected to the post of Assistant Law Officer/Labour Counsel.

**7. The selection of candidate having roll number 78000045 is purely on provisional basis subject to the verification of the disability certificate and degree of his disability by the user department before finally appointing him to the post.**

**8.** The candidature of candidates having roll number 78001396 & 78001363 who were in zone of selection/select panel has been rejected as the candidates have not uploaded e-dossier.

**9.** The selection of the above **06** Candidates shall be further subject to the thorough verification of the candidature of the candidate by the User Department including the identity of the candidate. The candidature of the candidate is liable to be cancelled by the User Department, in case candidate is found not fulfilling all the eligibility conditions of the Recruitment Rules of the post or any other genuine reason. The decision of the User Department/appointing authority regarding the eligibility of the candidate shall be the final and binding on the candidate.

**10.** The candidates who have availed the benefit of the reservation at the time of shortlisting of candidates for appearing in Tier-II examination on the basis of their Tier-I examination have been considered for final appointment in their respective category only. The User department shall also check the eligibility/admissibility of the reservation benefit in respect of candidates selected under reserved categories. Further, wherever applicable, User Department shall verify the genuineness of the caste/disability certificate furnished by the candidate prior to issuing offer of appointment to the candidate. The Competent Authority of the User Department shall arrange to verify the correctness of the information/ documents as furnished in the






application forms and e-dossier vis-à-vis the original documents. Further, the appointing authority shall also verify and satisfy itself about the authenticity of documents/certificates before finally appointing the candidates.

**11.** Mere inclusion of the name of the candidate in the Result Notice does not confer any right upon the candidate over the post unless the user department is satisfied after such inquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the post.

**12.** While every care has been taken in preparing the result, DSSSB reserves the right to rectify errors and omissions, if any detected at any stage.
