JUNIOR LAW OFFICER IN MUNICIPAL CORPORATIONS OF DELHI UNDER POST CODE 33/2012

- 1. The DSSSB vide its advertisement No 02/2012 with closing date 15.06.2012, had advertised 10 vacancies (UR-7, OBC-3 including PH(OH)-1) for the post of Junior Law Officerin Municipal Corporations of Delhi under **Post code 33/2012** in the pay scale of Rs. 9300-34800/- having Grade Pay of 4600/- (Pre- revised). The Board had conducted combined Tier I examination on 26.04.2015. The combined Tier II examination was conducted on 26.06.2016.
- 2. In view of the combined examination conducted for the two postcodes 33/12 and 47/13 of same user department, the Board has decided to give first preference to the candidate as per merit in postcode 47/13, which is having the higher grade pay amongst the two postcodes.
- 3. The marks of Tier-II examination was declared vide Notice No. 565 dated 02.11.2017 and e-dossiers from the shortlisted candidates have been obtained. On the basis of the merit list of Tier- II examination and after preliminary scrutiny of the candidature as per the provisions of the statutory Recruitment Rules for the post and the terms & conditions of the advertisement, the following candidates are provisionally selected to the post of Junior Law Officer.

- 8. The candidature of candidate having roll number **78000228**, **78001396**, **78000176**, **78600061** and **78001361**who were in zone of selection/select panel have been rejected as these candidates have not uploaded their edossier. Further the candidature of candidate having roll number **78000096** has been rejected being overage, he is not eligible for seeking age relaxation as admissible to Government Servants as per DOPT norms as the post of Assistant Teacher in Directorate of Education is not in the same or allied cadre for this post.
- 9. The selection of the above 10 Candidates shall be further subject to the thorough verification of the candidature of the candidate by the User Department including the identity of the candidate. The candidature of the candidate is liable to be cancelled by the User Department, in case candidate is found not fulfilling all the eligibility conditions of the Recruitment Rules of the post or any other genuine reason. The decision of the User Department/appointing authority regarding the eligibility of the candidate shall be the final and binding on the candidate.
- 10. The candidates who have availed the benefit of the reservation at the time of shortlisting of candidates for appearing in Tier-II examination on the basis of their Tier-I examination have been considered for final appointment in their respective category only. The User department shall also check the eligibility/admissibility of the reservation benefit in respect of candidates selected in reserved categories. Further, wherever applicable, User Department shall verify the genuineness of the caste certificate furnished by the candidate prior to issuing offer of appointment to the candidate. The Competent Authority of the User Department shall arrange to verify the correctness of the information/ documents as furnished in the application forms and e-dossier vis-à-vis the original documents. Further, the appointing authority shall also verify and satisfy itself about the authenticity of documents/certificates before finally appointing the candidates.
- 11. Mere inclusion of the name of the candidate in the Result Notice does not confer any right upon the candidate over the post unless the user department is satisfied after such inquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the post.
