1. The DSSSB vide its advertisement number 02/2014 with closing date 25/1/2015, had advertised 01 vacancy (UR-01) for the post of Deputy Vigilance Officer in Delhi Transport Corporation under Post code 216/2014. Board has conducted Tier-I examination for recruitment to this post on 31.5.2015. On the basis of the Tier-I examination 08 candidates were shortlisted for appearing in Tier-II examination vide CC-I Branch notice number 468 dated 20.05.2016.

2. The Tier-II examination for recruitment to this post was conducted 15.10.2017, wherein 05 candidates out of 08 candidates appeared in the examination. The combined marks of the Tier-II Examination (Objective and Descriptive) are being uploaded in the website. Candidates can view their marks by logging into their account in OARS module on www.dsssonline.nic.in.

3. Based on the performance in the Tier-II examination, 04 candidates having roll numbers **86003189, 86003200, 86003258 & 86003373** have been provisionally allowed to upload e-dossiers on attaining marks above minimum qualifying marks, subject to correctness of the information furnished by the candidates in their online application forms.
