# ACCOUNTANT IN DELHI AGRICULTURAL MARKETING BOARD UNDER POST CODE 61/2014

- 1. The DSSSB vide its advertisement number 01/2014 with closing date 27/02/2014, had advertised 02 vacancies (UR-02) for the post of Accountant in Delhi Agricultural Marketing Board under Post code 61/2014. Board has conducted Combined One Tier Examination (T) for recruitment to this post on 30.07.2017.
- 2. In the combined examination 37 candidates appeared for postcode 61/2014. Marks of 36 candidates whose OMR sheet have been evaluated have been uploaded on Board's website vide Notice number 630 dated 11.04.2018. The OMR of candidate having roll number 14903237 has not been evaluated as he has not bubbled his roll number in the relevant space/column, accordingly his candidature was cancelled. Simultaneously vide notice number 630 dated 11.04.2018, 04 candidates were shortlisted for uploading their e-dossiers.
- 3. After preliminary scrutiny of the candidature of candidates as per the provisions of the statutory Recruitment Rules for the post in respect of the educational qualification and the terms and conditions of the advertisement, the following candidates are provisionally selected to the post of Accountant in Delhi Agricultural Marketing Board under Post code 61/2014 for consideration of the remarks mentioned against each by the user department.

- 5. Candidature of candidate having roll number 14903358 has been kept as pending in postcode 61/14 for seeking additional documents for determining his eligibility for the post.
- 6. The selection of the above **01** Candidate shall be further subject to the thorough verification of the candidature of the candidate by the User Department including the identity of the candidate. The selection is purely provisional subject to admissibility of the experience details furnished by the candidate in reference to the provisions as prescribed in the RRs for the post by the User Department. DSSSB has not undertaken veracity/scrutiny of experience certificate being technical in nature. User Department may ensure their correctness at its own level.
- 7. The candidature of the candidate is liable to be cancelled by the User Department, in case candidate is found not fulfilling all the eligibility conditions of the Recruitment Rules of the post or any other genuine reason. The decision of the User Department/appointing authority regarding the eligibility of the candidate shall be the final and binding on the candidate.
- 8. The Competent Authority of the User Department shall arrange to verify the correctness of the information/ documents as furnished in the application forms vis-à-vis the original documents including the Graduation Degree and Experience Certification. Further, the appointing authority shall verify these documents and satisfy itself about the authenticity of documents/certificates before finally appointing the candidates.
- 9. Mere inclusion of the name of the candidate in the result notice does not confer any right upon the candidate over the post unless the appointing authority is satisfied after such inquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the post.
- 10. While every care has been taken in preparing the result, DSSSB reserves the right to rectify errors and omissions, if any detected at any stage.
