2. In the combined examination 08 candidates appeared for postcode 62/2014. Marks of all candidates were uploaded on Board's website vide Notice number 629 dated 11.04.2018. Simultaneously vide notice number 629 dated 11.04.2018, 02 candidates were shortlisted for uploading their e-dossiers.
3. After preliminary scrutiny of the candidature of candidates as per the provisions of the statutory Recruitment Rules for the post in respect of the educational qualification and the terms and conditions of the advertisement **no candidate was found suitable for selection** for the post of Accounts Clerk in Delhi SC/ST/OBC/ Minorities/Handicapped Financial & Development Corporation under Post code 62/2014.
4. Candidature of candidate having roll number 14903608 in UR category was cancelled as the candidate does not possess the requisite Govt./autonomous bodies experience.
5. Candidature of candidate having roll number 14903613 in SC category was cancelled as the candidate has not obtained 2nd Division as per the requirement of the RRs.
