RESULT NOTICE NO. 783 GRADE IV (DASS) (POST CODE 61/2015) IN SERVICES DEPARTMENT

- 1. The DSSSB vide Result Notice No. 690 dated 16/07/2018 and Result Notice No. 740 dated 16/11/2018 has provisionally selected 895 and 17 candidates respectively for the Post of Grade IV (DASS) in the Services Department under Post Code 61/2015 against the revised vacancies on the basis of the One Tier Written Examination held on 17/09/2017 and the skill test of Shortlisted candidates conducted with effect from 03/01/2018 to 14/01/2018 and 08/04/2018 (for VH category candidates).
- 2. User Department, i.e., Services Department, Govt. of NCT of Delhi has returned 28 Dossiers (UR-18, OBC-05, SC-04 and VH-01) on the grounds that candidates have not responded/Joined the post of Grade IV (DASS)/LDC. Hence the Board is declaring the result of Panel/Waitlisted Candidates.
- 3. Further, on the basis of the One Tier Written Examination held on 17/09/2017 and the skill test of Shortlisted candidates conducted with effect from 03/01/2018 to 14/01/2018 and 08/04/2018 (for VH category candidates), the following Candidates are hereby provisionally nominated as per their merit:-

- 3. There is no candidate in Select Panel in VH Category as such no candidate can be nominated against retuned dossier in this Category.
- 4. The Selection of the above 27 candidates (UR-13, OBC-10, SC-04) shall further be subject to genuineness of the documents on the basis of which they have claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of the advertisement inviting application and subject to thorough of their identity with reference their photographs, verification to signature/handwriting, etc. on the application form, admission certificate, etc. The Candidature of the above candidates are liable to be cancelled by the user department also, in case the candidates are found not to be fulfilling the terms and conditions of the advertisement inviting applications for the said post code. The Competent Authority of the Department concerned shall issue the appointment letters to the candidates after being satisfied about his/her eligibility as laid down in the Recruitment Rules and after verification of the correctness of the information furnished in the application form and the documents related to education qualification, age and other essential certificates as per Government of India instructions issued in this regards vide MHA OM No. 2/29/54-RPS, 19/11/54.
- 6. The User Department shall also get the SC/ST/OBC certificates verified from the issuing authority before his /her appointment. Further, in case of OBC Candidates, it may also be verified that the candidate does not belongs to creamy layer of the schedule of Govt. of India, DOPT O. M. No. 36012/22/93-Estt. (SCT) dated 08/09/1993 O. M. No. 36033/3/2004-Estt. (Res) dated 09/03/2004 and OM No. 36033/3/2004-Estt. (Res) dated 14/08/2008.
- 7. The candidates having roll number 15402218, 15416542, 15442122, 15421645 and 15417855 who were earlier selected in OBC category vide Result Notice No. 690 dated 16/07/2018 have now been shifted to the UR Category as per merit list.
- 10. If the candidate has any grievance regarding his/ her educational qualification/ age etc., he/she may approach the user department i.e. Services Department, GNCTD for necessary clarifications as the eligibility has been checked as per the terms & conditions provided by the user Department.

- 11. The result is subject to the outcome of the court cases pending in various courts related to this post.
- 12. The validity for remaining Wait List panel of the candidates will be valid up to 15/07/2019.
- 13. Mere inclusion of the name of candidate in the result notice does not confer any right upon the candidate over the post unless the appointing authority is satisfied after such enquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the Post.
- 14. While every care has been taken in preparing the result, the DSSSB reserves the right to rectify errors and omissions, if any.
