## SUPPLEMENTARY RESULT NOTICE NO: 681 DATED 09.10.2020

## EDUCATIONAL AND VOCATIONAL GUIDANCE COUNSELOR (FEMALE), POST CODE-149/17 IN DIRECTORATE OF EDUCATION.

The DSSSB vide its advertisement No. 04/2017 dated 20/12/2017 had advertised total 210 {UR-81, OBC-71, SC-39, ST-19 including PH OH-04, VH-03} for the post of EDUCATIONAL AND VOCATIONAL GUIDANCE COUNSELOR (EVGC) FEMALE Post Code-149/17 in Directorate of Education with closing date 31.01.2018. T-I examination in offline mode was conducted on 19/08/2018.

- On the basis of offline examination of T-I held on 19.08.2018 and having been found provisionally eligible as per documents uploaded in support of educational qualification, age, etc. in accordance with advertisement no. 04/2017 and RRs for the post of Educational and Vocational Guidance Counselor (EVGC) Female, Post Code-149/17 in Directorate of Education a total of 104 (UR-73, OBC-12, SC-19) candidates were provisionally nominated for the post of Educational and Vocational Guidance Counselor (EVGC) Female, Post Code-149/17 vide Result notice No. 361 dated 13.03.2019 and the candidature of 11 candidates were kept pending for want of documents/ clarification. Further, a total of 07 candidates (UR-03, OBC-03, SC-01) were provisionally nominated vide Supplementary Result Notice No. 489 dated 02.08.2019 and candidature of 04 candidates were kept pending for want of deficient documents in the e-dossier. These pending candidates were given 2<sup>nd</sup> and final opportunity to upload the deficient documents w.e.f. 07/08/2019 to 13/08/2019 but all the 04 candidates failed to upload the deficient documents in the e-dossier. Accordingly, 01 candidate under UR category below the merit had been taken into consideration and the candidature of 01 candidate under UR/PH (OH) category whose candidature had been revived, had also been taken into consideration for nomination vide Supplementary Result Notice No. 568 dated 23.12.2019. Further, 02 vacancies which have been kept pending under SC category, could not be filled up for non-availability of the qualified candidate in the respective category & returned to the user department.
- 3. Now, the User Department vide letter dated 24/02/2020 has returned the dossiers of 06 candidates (UR-04, SC-02) after cancellation of their candidature for not appeared for documents verification in the User Department/not fulfilling the eligibility criteria. Accordingly, 04 candidates (UR-04) have been taken into consideration from the waiting panel as per their merit. However, no qualified /suitable candidate available under OBC & SC category in the waiting panel and hence, these vacancies are being returned to the user department.
- 4. Accordingly, in continuation of Result Notice No. 370 dated 13.03.2019, Supplementary Result Notice No. 489 dated 02/08/2019, Supplementary Result Notice No. 568 dated 23.12.2019, the candidates, as detailed below, are provisionally selected on the basis of offline examination of Tier-I held on 19.08.2018 and having been found provisionally eligible as per documents uploaded in support of educational qualification, age etc. in accordance with

advertisement No. 04/17 and RRs for the post of Educational and Vocational Guidance Counselor (EVGC) Female, Post Code-149/17 in Directorate of Education:-

Note:- The candidate bearing Roll No. 2490000591 was earlier nominated vide result notice no. 370 dated 13.03.2019 under OBC category as per her merit. Since the merit of UR category became lower, her candidature is in the zone of consideration under UR category as per own merit candidate. Hence, this candidate is shifted from OBC category to UR category. The user department may update their record by modifying the result no. 370 dated 13.03.2019 and merit list accordingly.

- 5. The selection of the above candidates shall further be subject to genuineness of the documents on the basis of which they have claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of advertisement inviting applications and subject to thorough verification of their identity with reference to their photographs, signatures/handwriting etc. on the application form, admission certificate etc. The candidature of the above candidates are liable to be cancelled by the User Department also, in case the candidates are found not to be fulfilling the terms & conditions of the advertisement inviting applications for the said post code. The Competent Authority of the Department concerned shall issue the appointment letter to the candidates after being satisfied about their eligibility as down in the recruitment rules and after verification of the correctness of the information furnished in the application form and the documents related to Educational Qualification, Age and other essential certificates.
- 6. The user department shall also check the eligibility of the reservation benefit, if any. Further, if applicable, the User Department shall verify the genuineness of the Caste Certificates furnished by the candidates prior to issuing offer of appointment to the candidates. The Competent Authority of the user department shall arrange to verify the correctness of the information/documents as furnished in the e-dossier vis-à-vis the original documents. User Department is requested to ascertain the scrutiny /correctness of the same at their own level before issuing the offer of appointment to the provisionally selected candidates. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates and essential qualification for the post before finally appointing the candidate. The User Department is also requested to rectify/correct, in case, any minor/clerical error/deficiency noticed in the documents of the candidate at their own level.
- 7. It is stated that the User Department shall verify the genuineness of the caste certificate furnished by the candidate in the light of Notification No. 36012/22-93-Estt. (SCT) dated 08/09/1993 issued by DOPT and other instructions/guidelines issued from time to time by the Competent Authority prior to issuance of offer of appointment to the candidate. It is further stated that, prior to appointment, the User Department must satisfy, itself, that the above candidates are fulfilling the necessary criteria as prescribed for entitlement of OBC (Delhi) certificate as specified in various

## Orders/Guidelines/Circulars including order dated 07/03/2017 issued by Revenue Department, GNCTD after thorough verification of caste certificate.

- 8. The User Department shall also get the SC/ST/OBC/PH/ExSM/etc. certificates verified from the Issuing authority. Further, if applicable, User Department shall also verify the genuineness of the caste certificates furnished by the candidates prior to issuing offer of appointment to the candidates. In case of the OBC candidates, it may also be verified that the candidate does not belong to creamy layer of the schedule of Govt. of India, DoPT O.M. No. 36012/22/93-Estt. (SCT) dated 08.09.1993, O.M. No. 36033/3/2004-Estt. (Res) dated 09.03.2004 and 14.10.2009 and O.M. No. 36033/1/2013-Estt. (Res) dated 27.05.2013 & 13.09.2017.
- 9. The Competent Authority of the Department concerned shall issue the appointment letters to the candidates after being satisfied about his eligibility as laid down in the recruitment rules and after verification of the correctness of the information/documents as furnished in the application form and e-dossier vis-à-vis the original documents related to Educational Qualification, Age and other essential Certificates as per instructions issued by Govt. of India in this regard vide MHA O.M. No. 2/29/54-RPS, 19-11-54.
- 10. The user department shall ensure that the appointment made is in conformity with DoPT guidelines and instructions of Govt. issued from time to time.
- 11. The result process for the above post code stands closed in all respect except 03 vacancies which have been kept reserved for court case candidates.
- **12.** A waiting panel which was valid for a period of one year from the date of declaration of result i.e. upto **12.03.2020** has been expired.
- 13. Mere inclusion of name in the result notice does not confer any right upon the candidate over the post unless the User Department is satisfied after such inquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the post.
- 14. The category wise marks obtained by the last provisionally nominated candidate are as follows:
