1	2490001031	<p>The candidate is 34 years 06 days in age and overage by 04 years 06 days as on cutt of date i.e. 31.01.2018. The candidate has however, applied under DCF ctgy as she has worked in Rajasthan State Aids Control Society w.e.f. 22.05.2009 to 02.07.2013 &amp; Kendriya Vidyalaya on contract basis w.e.f. 02.07.2013 to 13.05.2014, 01.07.2014 to 28.02.2015 &amp; 21.04.2016 to 23.12.2017. As the candidate applied under DCF sub ctgy and worked as counselor in Kendriya Vidyalaya &amp; Rajasthan state aids control society, the age relaxation to autonomous body of Govt. of India is not applicable in Delhi Govt. posts. <b>Hence, the candidate is not eligible for being overage.</b></p> <p>As per circular/instructions issued by Directorate of Education, relaxation in the upper age limit as a onetime measure upto the actual time spent as guest/contract teacher in Dte. Of Education, subject to a maximum of 05 years provided they have worked for atleast 120 days in that particular year. (this would be applicable to those guest/contract teachers who have worked for the academic years 2012-13, 2013-14, 2014-15, 2015-16 &amp; 2016-17.</p>
