1. The DSSSB vide its advertisement No. 01/2014 had advertised **27 vacancies (UR-11, OBC-08, SC-05, ST-03 including EXSM-03, and PH-OH-01)** for the post of Instructor Drawing under Post Code-101/14 in Directorate of Training and Technical Education, GNCTD.
2. The marks obtained by **244 candidates** who have duly appeared in written examination held on **29.09.2019** have been uploaded on the Board's website. **Further, vide Notice no. 950 dated 18.12.2019, e-dossiers were called w.e.f. 20.12.2019 to 03.01.2020. Cut off date for the said post code was 27.02.2014.**
3. Vide result notice No. 1045 dated 24.02.2020, the candidature of **02 candidates (UR-01, OBC-01)** was kept pending for want of deficient documents required as per RRs. E-dossier link was activated (first recall w.e.f. 28.02.2020 to 08.03.2020).
4. Vide notice No. 1099 dated 23.06.2020, the candidature of **02 candidates (UR-01, OBC-01)** was kept pending for want of deficient documents required as per RRs. E-dossier link was activated (second and final recall) w.e.f. **25.06.2020 to 29.06.2020** in respect of these **02 candidates (UR-01, OBC-01).**
5. On scrutiny of marks secured in the written examination and after preliminary scrutiny as per the provision of the statutory Recruitment Rules for the post of **Instructor Drawing under Post Code 101/14 in Directorate of Training & Technical Education, GNCTD** and the terms and conditions of the advertisement, the candidature of **one (01) candidate** bearing following Roll No. in respect of the said post code is rejected for the reason/remarks mentioned against the roll number as below :-
