1. The DSSSB vide its advertisement No.01/2017 had advertised **total 260 vacancies (UR-79, OBC-100, SC-46,ST-35 including PH (OH-02,HH-05, VH-04 & Autism/Multiple disability-05)** for the post of **Statistical Assistant under Post Code 04/17 in Planning Department, GNCTD**. Later on the same were revised vide addendum dated 07.11.2019 and the modified vacancies are **273 vacancies (UR-88, OBC-102, SC-47, ST-36 including PH (OH-02,HH-05,VH-04 & Autism/Multiple disability-05)**
2. The marks (normalized) obtained by **2284 candidates** who have duly appeared in written examination held on 27.11.2019 have been uploaded on Board's website. Candidates can view their marks by logging into their account in OARS module on www.dsssonline.nic.in. Further, vide Notice no. 1083 dated 16.03.2020, **the e-dossiers were called w.e.f. 18.03.2020 to 01.04.2020.**
3. **It is stated that in view of the extra-ordinary circumstances arising out of the COVID-19 pandemic, wherein the entire country had to be placed in a complete lockdown w.e.f.24th march, 2020 (Midnight) to 18th May, 2020 and during that period all physical movement of citizens were curtailed and all markets/services closed by Govt. of India and it was declared illegal to make routine/general movement. Since, during the above period the complete Lockdown was enforced by the Govt., therefore, the following 52 candidates who could not be able to upload their e-dossiers in above period, are hereby given another last and final opportunity for uploading their e-dossiers, as details given below:**

4. The above candidates for the above mentioned post code are hereby informed to fill the e-dossier and upload all the documents of Educational/Professional Certificate/Degree and Mark sheets/Caste certificate/Disability certificate/Proof of Govt. Servant/Ex. Serviceman/Admit Cards etc., as applicable in the e-dossier module in OARS link in their individual account.
5. Kindly note that the e-dossier link will be activated to only those candidates who are in the consideration zone of selection.

6. All the candidates who have been shortlisted for falling in the consideration zone of selection **MUST** upload their all requisite / applicable documents in the said link in stipulated time.
7. The e-dossier link shall be active from 04.09.2020 to 18.09.2020. The candidate uploading e-dossier should ensure that he/she fulfils all the eligibility criteria/all essential qualifications as per RRs for the post as on the cut-off date i.e 21.08.2017. The above shortlisted candidates are also being separately informed through SMS and E-mail on their registered mobile number and E-mail Id (as an additional facility). If, any candidate fails to upload e-dossier during the above said period his/her candidature will be rejected and no further opportunity will be given on whatsoever ground.
- 8 Mere asking the candidate for uploading documents in the e-dossier module does not confer him/her right to selection to the applied post. Final selection will be made purely on the basis of merit against the notified vacancies provided the candidate falling in the zone of consideration fulfils all the required eligibility conditions. It is reiterated that if the candidate fails to upload his/her documents on or before the date as mentioned above he/she will not be given any further opportunity and his/her candidature will be treated as cancelled.
- 9 While every care has been taken in preparing the list of shortlisted candidates, DSSSB reserves the right to rectify errors and omissions if any, detected at any stage.
- 10 The above calling of e-dossier for the post of Statistical Assistant under post code 04/17, in Planning Department is subject to outcome of pending courts cases, if any.
