## NOTICE NO: 1184 ASSISTANT LAW OFFICER UNDER POST CODE 31/15 IN NDMC.

- The DSSSB vide its advertisement No.01/2015 had advertised 04 vacancies (UR-02, OBC-01, SC-01, including 01 PH-VH-LV) for the Post of Assistant Law Officer under Post Code 31/15 in NDMC.
- 2. Tier-I offline examination was held on 08.09.2019. Further, the result of Tier-I examination was declared vide result notice no. 844 dated 10.10.2019.
- 3. Further, as per examination policy Two Tier Examination (T2) was held on 23.02.2020 and the marks obtained by 35 candidates who duly appeared in Two Tier Examination (T2) conducted (offline mode) on 23.02.2020 have been uploaded in OARS module on <a href="https://www.dsssbonline.nic.in">www.dsssbonline.nic.in</a>.
- 4. Based on the performance in Two Tier Examination (T2), the candidates who have secured equal and more marks in their respective category as per details given are being provisionally shortlisted and informed in their OARS module to upload e-dossier subject to attaining minimum qualifying marks and correctness of the information furnished by the candidates in their e application forms.

Note: \*The candidate having roll No. 4760000012 having date of birth 19.05.1982, being older in age than other candidate having equal marks is the last shortlisted candidate in SC category for dossier calling.

- 5. The shortlisted candidates for the above mentioned post code are hereby informed to fill the e-dossier and upload all the documents of Educational/Professional Certificate/Degree and Mark sheets/Caste Certificate/Disability certificate/Proof of Govt. Servant/Ex. Servicemen/Admit Cards etc., as applicable in the E-dossier module in OARS link in his individual account in OARS module. Short listing is being made on the basis of marks obtained in Two Tier examination (T2) for 250 marks.
- Kindly note that the e-dossier link will be activated to only those candidates who
  are provisionally shortlisted to upload e-dossier as per details given in para 4
  above.
- 7. The candidate who has been shortlisted for falling in the consideration zone of selection MUST upload his/her all requisite/applicable documents in the said link in stipulated time.

- 8. The e-dossier link shall be activated for a period of 15 days w.e.f. 25.09.2020 to 09.10.2020.
- 9. The candidate uploading e-dossier should ensure that he/she fulfils all the eligibility criteria as on the cut-off date, i.e. 26.11.2015 as per Advertisement No 01/15. As an additional facility, the shortlisted candidate is also being separately informed through SMS & E-Mail on their registered mobile number & e-mail id. If, the candidate fails to upload the e-dossier during the above said period, his/her candidature will be rejected and no further opportunity for uploading e-dossier will be given on whatsoever ground.
- 10. Mere asking the candidate for uploading documents in the e-dossier module does not confer him/her any right to selection to the applied post. Final selection well be made purely on the basis of merit against the notified vacancies provided the candidate falling in the zone of consideration fulfils all the required eligibility conditions. It is reiterated that if the candidate fails to upload his/her documents on or before the date as mentioned above he/she will not be given any further opportunity and his/her candidature will be treated as cancelled.
- 11. This above shortlising shell be subject to outcome of court case WPC No. 3006/2016 in OA No. 4643/2015 and other relevent court cases, if any.
