ORDER

Auxiliary Nurse Midwife In Health & Family Welfare Department, Post Code 12/18

- 1. This order is being passed in compliance of the directions of Ld. CAT issued vide its order dated 25.06.2020 in OA No. 832/2020 in the matter of Pooja Rani Vs. GNCTD & Ors. The observation/direction of Ld. CAT is as under:-
 - "6. Be that it may, we are of the considered view that once the applicant has qualified the requisite examination, she deserves to be informed of the reasons for being denied the offer of appointment.
 - 7. In the facts and circumstances, without going into the merits of the claim of the applicant, we dispose of the OA with the direction to respondent no. 1 to consider the aforesaid representations (Annexure A-8 colly) of the applicant and to dispose of the same by passing a reasoned and speaking order as expeditiously as possible and in any case, within eight weeks of receipt of a certified copy of this order.
 - 8. The OA is disposed of in the aforesaid terms. However, in the facts and circumstances, no order as to costs."
- 2. In compliance of above order, the representation/case of the applicant i.e. Ms. Pooja Rani (Roll No. 11151400333) has been examined and it is hereby informed that:-
 - (i) That the Board vide its advertisement No. 02/2018 dated 05/07/2018 with closing date as 13.08.2018 had advertised 89 vacancies [UR-45, OBC-24, SC-13, ST-07, OH(OL)-04, EXSM-09] for the post of Auxiliary Nurse Midwife in Health and Family Welfare Department. The eligibility for the post is determined as per the RRs of the post as supplied by the user department.

(ii) That the educational qualification, age, experience, etc. as stipulated in advertisement shall be determined as on the closing date, i.e., 13/08/2018 of submission of application. The Educational and other qualifications as per RR is as under:-

Qualifications:- Essential:-

1. Registered Auxiliary Nurse Midwife.

Desirable: - NIL.

Experience: - Essential:- Nil.

Desirable: - Some Experience and training in family planning.

- (iii) That the applicant had applied for the post of Auxiliary Nurse Midwife in Health and Family Welfare Department under post code 12/18 in OBC Category and allotted Roll No. 11151400333. She obtained minimum qualifying marks in written examination, accordingly, she shortlisted for uploading documents e-dossier in OARS. Dossiers were called from all the shortlisted candidates including the applicant Ms. Pooja Rani and the e-dossier link for shortlisted candidate was opened between 15.01.2020 to 29.01.2020
- (iv) After scrutiny of documents uploaded by applicant in her e-dossier, her candidature was kept pending in OBC category vide Result Notice No. 958 dated 02.03.2020, as the applicant Ms. Pooja Rani (Roll No. 11151400333) did not uploaded documents related to registration with Nursing Council prior to cut off date i.e. 13/08/2018. Further, the opportunities were given to the applicant vide Result Notice No. 958 and 991 respectively, to upload her pending documents through e-dossier link on OARS module of the Board within stipulated time. But candidate failed to upload requisite document in OARS i.e. registration certificate with nursing council prior to cut off date i.e. 13.08.2018.
- 3. Further, the candidate has attached certificate of registration with Delhi Nursing Council vide registration no. 76480 dated 20.08.2018 with application of above said OA, filed by the candidate before Ld. CAT.
- 4. As per that certificate, the candidate registered with Nursing Council on 20.08.2018, which is after cut off date i.e. 13.08.2018, hence, candidate don't have essential qualification as per RRs for the post of Auxiliary Nurse Midwife in Health and Family Welfare Department under post code 12/18 as on cut off date.

5. Considering above said facts, the candidature of the applicant namely Ms. Pooja Rani having roll no. 11151400333 is hereby rejected for the post of Auxiliary Nurse Midwife in Health and Family Welfare Department under post code 12/18, since, candidate does not have essential educational qualifications as per RRs of the said post as on cut off date i.e. 13.08.2018
