- 1. This is in continuation of the Result 1054 dated 03.03.2020.
- 2. The Board had advertised vide Advt. No. 1/14 for 803 vacancies (UR-290, OBC-126, SC-282, ST- 105) for the post of Fire Operator in Delhi Fire Service under Post Code 71/14. The closing date of application /cut off date was 27/02/2014. An addendum was issued on 26.05.2015 vide which the vacancies had been increased from 803 to 841 vacancies (UR-321, OBC-126, SC-288 & ST-106) for the post of Fire Operator in the pay scale of Rs 5200-20200 + Grade Pay Rs 2000/- + special allowance, risk pay, washing allowance in the Department of Delhi Fire Service under Post code 71/2014. Board has conducted written test for this post on 31.08.2014, thereafter Physical Endurance Test was conducted by DSSSB from 17.06.2016 to 29.06.2016 and driving skill test was conducted by DFS from 01.09.2017 to 22.09.2017.
- **3.** The marks of Written + PET + Driving was uploaded on Board's website. Vide result notice 606 dated 16.11.2017.
- **4.** Further, candidature of the following candidate having roll no. 15005797 was kept pending vide Notice No. 1054 dated 03.03.2020, and the candidate was directed to upload deficient documents through e-dossiers module on OARS w.e.f. 06.03.2020 o 15.03.2020.
- **5.** The said candidate did not upload the deficient documents within the stipulated time and hence, his candidature is still kept pending due to reasons mentioned in the remarks column:-

The above one candidate (UR-01) whose documents are deficient, is once again directed to upload his/her deficient documents/all requisite/applicable documents etc, if any, through the e-dossier module (2nd recall & final opportunity) in stipulated period i.e. from 28.09.2020 to 02.10.2020 failing which his candidature will be rejected and no further opportunity will be given on whatsoever ground.
