- The DSSSB vide its advertisement No. 02/18 had advertised 178 vacancies (UR-83, OBC-56, SC-14, ST-25 including PH-OH-16 and EXSM-68) for the post of Lab Assistant (Group-IV) under Post Code-13/18 in Health & Family Welfare Department, GNCTD.
- 2. The examination (online mode) was conducted on 30.08.2019.
- 3. The marks obtained by **3495 candidates** who have duly appeared in the online examination held on **30.08.2019** have been declared vide Notice No. 959 dated 20.12.2019 and e- dossiers were called between the period w.e.f. 24.12.2019 to 07.01.2020.
- 4. The candidature of 11 candidates was kept pending for want of deficient documents vide supplementary result notice no. 1156 dated 04.08.2020. Edossier link was activated from 11.08.2020 to 20.08.2020.
- 5. The result has been processed keeping in view of the eligibility conditions and relaxation thereof in respect of educational qualifications etc. as on cut off date i.e. 13.08.2018 for the Post Code- 13/18.
- 6. On scrutiny of marks secured in the written examination and after preliminary scrutiny as per the provision of the statutory Recruitment Rules for the post of Lab Assistant (Group-IV) under Post Code-13/18 in Health & Family Welfare Department, GNCTD and the terms and conditions of the advertisement, the candidature of the candidates bearing following Roll Nos. in respect of the said mentioned post code is rejected for the reason/remarks mentioned against each roll number. :-
