RESULT NOTICE NO. 1197 ASSISTANT DIRECTOR (COMMUNITY SERVICES) UNDER POST CODE- 48/13 IN MCD

- The DSSSB vide its advertisement No.03/2013 had advertised total 05 vacancies (UR-03, OBC-01, ST-01 including PH(OH)-01) for the Post of Assistant Director (Community Services) under Post Code- 48/13 in MCD. Board Conducted Tier-I examination (online mode) for recruitment in respect of this post on on 19/09/2019. Based on the performance in Tier-I examination (online mode), vide Notice No. 877 dated 16/01/2020, 28 (Twenty Eight) candidates, were provisionally shortlisted to appear in Tier-II examination (online mode).
- 2. The online Tier II examination was held on 04/04/2021 and a total of 26 candidates appeared out of the 28 candidates. Vide **Notice No. 1145 dated 11/06/2021**, the marks statements of the above Post/Post Code have been uploaded the Board's website for information of the candidates. Candidates can view their marks by logging onto their account in OARS module on www.dsssbonline.nic.in.
- 3. On the basis of Tier-II examination held on 04/04/2021 and having been found provisionally eligible as per documents uploaded in support of Educational Qualification, Age, etc. in accordance with the advertisement no. 03/2013 and RRs for the Post of Assistant Director (Community Services) under Post Code- 48/13 in MCD, the following Candidates are hereby provisionally nominated as per their merit:-

- * Note: That as per RRs, essential experience is "03 year experience in responsible capacity in Social Work/Community Organization/Public Relation or Publicity in a recognized Social Organization", since the essential experience related to fair knowledge and experience of social work/Community Organization/Public Relation or Publicity is technical in nature therefore, at this stage DSSSB has not undertaken the veracity/scrutiny of the essential experience furnished by the candidates as such User Department i.e. MCD is requested to ascertain the scrutiny/correctness of the same at their own level before issuing the offer of appointment to the proposed candidate as per nature of job and requirements of the Department. The selection is provisional and subject to satisfaction of User Department regarding essential experience furnished by above candidates.
- 4. The selection of the above **02 candidates (UR-02)** shall be further subject to thorough verification of the candidature of the candidate by the User Department including the identity of the candidate.
- The Selection of the above 02 candidates (UR-02) shall further be subject 5. to genuineness of the documents on the basis of which they have claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of the advertisement inviting application and subject to thorough verification of their identity with reference to their photographs, signature/handwriting, etc. on the application form, admission certificate, etc. The Candidature of the above candidates are liable to be cancelled by the user department also, in case the candidates are found not to be fulfilling the terms and conditions of the advertisement inviting applications for the said post code. The Competent Authority of the Department concerned shall issue the appointment letter to the candidates after being satisfied about their eligibility as down in the recruitment rules and after verification of the correctness of the information furnished in the application form and the documents related to Educational Qualification, Age and other essential certificates.
- 6. The User Department shall also check the eligibility of the reservation benefit, if any. Further, if applicable, the User Department i.e. MCD shall verify the genuineness of the caste certificate furnished by the candidate prior to issuing offer of appointment to the candidates. The Competent Authority of the User Department shall arrange to verify the correctness of the information/documents as furnished in the e-dossier vis-à-vis the original documents. User Department is requested to ascertain the

scrutiny/correctness of the same at their own level before issuing the offer of appointment to the provisionally selected candidates. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates and essential qualification for the post before finally appointing the candidate. The User Department is also requested to rectify/correct, in case, any minor/clerical error/deficiency noticed in the documents of the candidate at their own level.

- 7. It is stated that the User Department shall verify the genuineness of the caste certificate furnished by the candidate in the light of Notification No. 36012/22-93-Estt. (SCT) dated 08/09/1993 issued by DOPT and other instructions/guidelines issued from time to time by the competent authorities prior to issuance of offer of appointment to the candidate. It is further stated that, prior to appointment, the User Department must satisfy, itself, that the above candidates are fulfilling the necessary criteria as prescribed for entitlement of OBC (Delhi) certificate as specified in various Orders/Guidelines/Circulars including order dated 07/03/2017 issued by Revenue Department, GNCTD after thorough verification of caste certificate.
- The User Department shall also get the SC/ST/OBC certificates verified from 8. the issuing authority before his /her appointment. Further, in case of OBC Candidates, it may also be verified that the candidate does not belongs to creamy layer of the schedule of Govt. of India, DOPT O. M. No. 08/09/1993 No. (SCT) dated 36012/22/93-Estt. OM 36033/3/2004-Estt. (Res) dated 09/03/2004 and No. 14/10/2008 and MO No. (Res) dated 36033/3/2004-Estt. 36033/I/2013-Estt. (Res) dated 27/05/2013 & 13.05.2017.
- 9. The Competent Authority of the Department concerned shall issue the appointment letters to the candidates after being satisfied about his/her eligibility as laid down in the Recruitment Rules and after verification of the correctness of the information furnished in the application form and the documents related to education qualification, age and other essential certificates as per Government of India instructions issued in this regards vide MHA OM No. 2/29/54-RPS, 19/11/54.
- 10. The User Department shall ensure that the appointment made is in conformity with DOPT guidelines and instructions of Govt. issued from time to time.
- 11. Mere inclusion of the name of candidate in the result notice does not confer any right upon the candidate over the post unless the appointing authority is satisfied after such enquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the Post.
