1. The DSSSB vide its advertisement no. 03/2020 dated 03/01/2020 with closing date 20/02/2020 had advertised 04 vacancies (**UR-02, OBC-02**) for the Post of Senior Scientific Assistant (Biology) under post code 58/20 in Forensic Science Laboratory.
2. The written examination (online mode in single shift) Tier-I (Technical) for recruitment in respect of this post was conducted on 18/09/2021.
3. Whereas all candidates were instructed vide clause 7 (viii) of the said advertisement that the educational qualification, age, experience, and other eligibility conditions against the post shall be determined as on the closing date of online submission of application.
4. Whereas all candidates were informed vide clause 5 (ii) of the said advertisement that Candidates who wished to be considered against reserved vacancies and/or to seek age relaxation, must be in possession of relevant certificates (SC/ST/OBC/Non Creamy layer/PH/Educational/Experience, etc.) issued by the competent/notified authority (in prescribed format) on or before the cutoff date (closing date of advertisement) otherwise their claim for any category will not be entertained and their applications will be considered against Un-reserved (UR) category vacancies, if eligible otherwise.
5. Whereas all candidates who have been shortlisted for calling e-dossiers have been informed to upload e-dossier from 15/11/2021 to 29/11/2021 vide Notice No.1309 dated 09/11/2021.
6. Whereas on scrutiny of the documents uploaded by the candidates in the e-dossier module, the candidates, having roll no. mentioned below, have also been informed through 1st recall notice No.1321 dated 09/12/2021 and 2nd recall/final notice no.1333 dated 28/12/2021 and directed to upload the deficient documents from 09/12/2021 to 18/12/2021 and 29/12/2021 to 02/01/2022 respectively.

7. Whereas the following candidates have been found to be 'Not Eligible' in terms of the advertisement no. 04/2020 dated 04/01/2020 and Recruitment Rules for the Post of Senior Scientific Assistant (Biology) under post code 58/20 in Forensic Science Laboratory, GNCTD and their candidatures stands rejected with the following reasons:-

1	121205800211	OBC(D)	Whereas proper opportunities provided to the candidate to upload the requisite document as per RRs. And whereas candidate has uploaded the documents of educational qualification i.e. degree and marks sheet of B.Sc. (Hons) in Biochemistry & M.Sc. (Bio-medical Science). And whereas a clarification has been asked from the user department i.e. Forensic Science Laboratory in respect of the said qualification. And whereas the user department i.e. FSL has informed that the qualification the candidate is not as per existing RR for the post of Senior Scientific Assistant (Biology). In view of same, the candidate cannot be treated as eligible for the post of Senior Scientific Assistant (Biology) in Forensic Science Laboratory. Therefore the candidature of the candidate is rejected in the post code 58/20 in absence of essential educational qualification as per RRs on cutoff date i.e. 23.02.2020.
2	121205800131	OBC(D)	Whereas proper opportunities provided to the candidate and the candidate has submitted in his e-dossier, the OBC certificate No. 90509721077317 dated 15.07.2015 and NCL certificate dated 03.04.2019 vide which he has been declared that he belongs to OBC Community of Govt of India which is for applying for appointment to the post under Govt. of India. It is evident that the candidate is not having OBC (Delhi) certificate issued under Notification No.F.28(93)/91-92/SC/ST/P&S/4384 dated 20.01.1995, F.(8)/11/99-2000/DS/CST/SCPOBC/2855 dated 31.05.2000 and F.8(6)/2000-01/DSCST/SC/OBC/2855 dated 31.05.2000 and F.8(6)/2000-01/DSCST/SC/OBC/11677 dated 05.02.2004 & 21.11.2017. Since the candidate was not having OBC (Delhi) Certificate on 20.02.2020 in accordance with clause 5 (ii) of advertisement no. 03/20 dated 03.01.2020 his claim for OBC (Delhi) category has not been entertained. His application has been considered
