The DSSSB vide result Notice no 434 dated 10.10.16 has declared the result of 13 candidates for the post of *Post Graduate Teacher (Math) (female)* in Directorate of Education under **Post code 142/2012**.

The candidature of the candidates having Roll number 32000428 and 32002260 were kept pending in UR and OBC category on account of court cases OA No 2161/16 and 2226/15 respectively. The OA no 2226/15 in the matter of Prabhjot Kaur Vs DSSSB and ors has been disposed off as infructuous vide order dated 27.2.17. The court case No 2161/16 in the matter of Anshu Tyagi vs DSSSB is still under consideration with Ld CAT. Accordingly, the candidature of the candidate having Roll number 32000428 in UR category shall remain pending and the candidature of the candidate 32002260 were in OBC category is being considered as per the merit.

Further, the candidature of candidate having Roll no 32002023 was kept pending in postcode for seeking clarification from User Department regarding eligibility of the candidate on the basis of PG qualification furnished by them. On receipt of the clarification vide letter dated DE/2/8/PGT Clari/E-II/2016/552 dated 3.3.17 from the Directorate candidate.

In view of above and on the basis of the merit list of Tier- II examination and after preliminary scrutiny of the candidatures as per the provisions of the statutory Recruitment Rules of the post and the terms and conditions of the advertisement, the following candidates are provisionally selected to the post of PGT (*Math*) Female **Post code 142/2012**:

The selection of the above 02 Candidates shall be further subject to through verification of the candidature of the candidates by the User Department. The candidature of the candidates is liable to be cancelled by the User Department, in case, candidate is found not fulfilling all the eligibility conditions of the Recruitment Rules of the posts or for any other genuine reason. The decision of the User Department/appointing authority regarding the eligibility of the candidate shall be final and binding on the candidate.

The candidates who have availed the benefit of the reservation at the time of shortlisting of candidates on the basis of Tier I written examination have been considered for final appointment in their respective category only. The User department shall also check the eligibility of the reservation benefit, if any. Further, if applicable, User Department shall verify the genuineness of the caste certificate furnished by the candidate prior to issuing offer of appointment to the candidates. The Competent Authority of the User Department shall arrange to verify the correctness of the information/ documents as furnished in the application forms vis-à-vis the original documents. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates before finally appointing the candidates.

Mere inclusion of the name of the candidate in the result notice does not confer any right upon the candidate over the post unless the appointing authority is satisfied after such inquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the post.
