POST GRADUATE TEACHER (Math) (MALE) IN DIRECTORATE OF EDUCATION UNDER POST CODE 181/2014

The DSSSB vide result Notice no 431 dated 10.10.16 and corrigendum dated 20.10.16 had declared the result of 08 candidates for the post of *Post Graduate Teacher (Math) (Male)* in Directorate of Education under **Post code 181/2014**.

The candidature of the candidates having Roll number 32000588 in UR category was kept pending due to court case OA 2223/15. In the court case 2223/2015 in the matter of Kavita Bashista & Ors including Girish Kumar Chaudhary (32000580) vs GNCTD, Ld CAT in its hearing dated 28.04.2016 has dismissed the case in default. Accordingly, the candidature of the candidate having Roll number 32000588 in UR is being considered as per the merit.

Further, the candidatures of candidate having Roll no 32000865 and 32002006 were kept pending in postcode for seeking clarification from User Department regarding eligibility of the candidate on the basis of PG qualification furnished by them. On receipt of the clarification vide letter dated DE/2/8/PGT Clari/E-II/2016/552 dated 3.3.17 from the Directorate candidate.

In view of above and on the basis of the merit list of Tier- II examination and after preliminary scrutiny of the candidatures as per the provisions of the statutory Recruitment Rules of the post and the terms and conditions of the advertisement, the following candidates are provisionally selected to the post of PGT (*Math*) Male **Post code 181/2014**:

The selection of the above 03 Candidates shall be further subject to through verification of the candidature of the candidates by the User Department. The candidature of the candidates is liable to be cancelled by the User Department, in case, candidate is found not fulfilling all the eligibility conditions of the Recruitment Rules of the posts or for any other genuine reason. The decision of the User Department/appointing authority regarding the eligibility of the candidate shall be final and binding on the candidate.

The candidates who have availed the benefit of the reservation at the time of shortlisting of candidates on the basis of Tier I written examination have been considered for final appointment in their respective category only. The User department shall also check the eligibility of the reservation benefit, if any. Further, if applicable, User Department shall verify the genuineness of the caste certificate furnished by the candidate prior to issuing offer of appointment to the candidates. The Competent Authority of the User Department shall arrange to verify the correctness of the information/ documents as furnished in the application forms vis-à-vis the original documents. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates before finally appointing the candidates.

Mere inclusion of the name of the candidate in the result notice does not confer any right upon the candidate over the post unless the appointing authority is satisfied after such inquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the post.

While every care has been taken in preparing the result, DSSSB reserves the right to rectify errors and omissions, if any detected at any stage.
