The DSSSB vide result Notice no 432 dated 10.10.16 and corrigendum dated 20.10.2016 has declared the result of 2 candidates for the post of *Post Graduate Teacher (Math) (female)* in Directorate of Education under **Post code 182/2014**.

The candidature of the candidate having Roll number 3200154 was kept pending in UR and OBC category on account of court cases 2226/15. The OA no 2226/15 in the matter of Prabhjot Kaur Vs DSSSB and ors have been disposed off as infructuous vide order dated 27.2.17, accordingly, the pending candidature of the candidate is being considered as per the merit.

Further, the candidature of this candidate was further kept pending in for seeking clarification from User Department regarding eligibility of the candidate on the basis of PG qualification furnished by them. On receipt of the clarification vide letter dated DE/2/8/PGT Clari/E-II/2016/552 dated 3.3.17 from the Directorate candidate.

The selection of the above 01 Candidate shall be further subject to through verification of the candidature of the candidate by the User Department. The decision of the User Department/appointing authority regarding the eligibility of the candidate shall be final and binding on the candidate.

Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates before finally appointing the candidates.

Mere inclusion of the name of the candidate in the result notice does not confer any right upon the candidate over the post unless the appointing authority is satisfied after such inquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the post.
