**MOTOR VEHICLE INSPECTOR (POST CODE 64/2015)
IN TRANSPORT DEPARTMENT**

The DSSSB vide its advertisement No 01/2015 with closing date 26.11.2015, had advertised 13 vacancies (UR-06, OBC-05, SC-02) for the post of Motor Vehicle Inspector in Transport Department under Post Code 64/2015. Board conducted Tier-I written examination for recruitment in respect of this post on 05.03.2017. Marks of the candidate have been uploaded on Board's website. Based on the performance in Tier-I written examination, 21 (twenty one) candidates who have obtained marks above the cutoff marks, as detailed below, have been provisionally shortlisted to appear in Tier-II exam, subject to their fulfilling all other conditions of eligibility and also correctness of the information furnished by the candidates in their online application forms. The short listed candidates shall be called for Tier-II exam separately.

The candidate having Roll number 12300126 has not been shortlisted in UR category as he is overage in UR Category. Further he has not been considered in OBC category as he belongs to OBC (outsider) as per his declaration in OMR.

The candidates having Roll number 12300111, 12300214, 12300284 have not been considered in OBC category as they belong to OBC (outsider) as per their declaration in OMR

Reserved category candidates (OBC, SC) have been shortlisted for appearing in Tier-II Exam, on the basis of details provided by them in their online application forms as well as in OMR answersheets. Since documents have not been called from the candidates alongwith application forms as such detailed scrutiny regarding their eligibility has not been carried out, and therefore, mere inclusion of names in the list of candidates qualifying for appearing in Tier-II examination does not entitle them any right over the post.

The shortlisting of the candidates for appearing in Tier-II Examination is purely provisional, subject to verification of credentials & documents for determination of eligibility for the post to be carried out by the Board after completion of Tier-II Examination.

Reserved category candidates who have obtained marks above or equal to the last shortlisted UR candidate have been shortlisted against UR vacancies and their final selection to the post shall be considered in UR category, subject to availability of vacancies, otherwise for selection in their respective category.

As per the Board notice dated 26.04.2013, the minimum qualifying marks in two tier written examinations for General candidate is 40%; for OBC candidate is 35%, for SC/ST/PH candidate is 30% and for Exsm candidate is 5% relaxation in their respective categories subject to a minimum of 30%.

The qualified candidates for appearing in Tier-II Examination has been called in the ratio 1:10 of the advertised vacancies, while taking all the candidates who have scored marks equal to the cut off marks for each category for short listing, subject to scoring the marks above minimum cut off marks. Final selection against advertised vacancies shall be made in accordance with the merit list drawn as per result of the written examination subject to availability of vacancies and the candidates qualifying the Tier-II Examination and also fulfilling of all the conditions of eligibility as prescribed in the RRs of the post and terms and conditions of the advertisement.

Shortlisted candidates shall be called for Tier-II examination separately.

While every care has been taken in preparing the result, DSSSB reserves the right to rectify errors and omissions, if any detected at any stage.
