RESULT NOTICE NO- 511 ASSISTANT SUPERINTENDENT UNDER POST CODE 38/2013 IN DELHI PRISONS DEPARTMENT

The DSSSB vide its advertisement No 02/2013 with closing date 02/08/2013, had advertised 35 vacancies (UR-19, OBC-09, SC-05, ST-02 Later, 04 vacancies were reserved for Ex-servicemen) for the post of Assistant Superintendent in Delhi Prisons Department in the pay scale of Rs. 5200-20200 having Grade Pay of 2800/- (Group C Jail Cadre) under postcode 38/2013. The Board had conducted the written examination for post of Assistant Superintendent under Post code 38/2013 on 09.03.2014. After conducting the Physical Endurance Test (PET-I) in respect to shortlisted candidates from 16.03.2015 to 22.03.2015, the final result was declared vide Result Notice No. 342 dated 15.10.2015; and subsequent Result Notice No. 350 dated 18.12.2015 and Result Notice No 367 dated 14.01.16, whereby Board had nominated 15 candidates (07 UR, 08 OBC) under post code 38/13 for the post of Assistant Superintendent.

Later, on the request of the user department for nominating the candidates for the unfilled vacancies, the cutoff marks for short listing the candidates for appearing in Physical Endurance Test (PET-II) were reduced and vide Notice No 395 dated 15.06.2016. The Physical Endurance Test for the candidates shortlisted on 15.06.2016 was conducted from 12.07.2016 to 13.07.2016. On the basis of the merit list of written examination and consequent upon qualifying the PET-II, vide Result Notice No. 415 dated 28.07.2016 Board had further nominated 09 candidates (06 UR, 01 OBC, 02 UR/EX) under post code 38/13 for the post of Assistant Superintendent.

On account of change in the cut-off marks of last selected in UR category vide Result Notice dated 28.07.2016, the following candidates who were previously selected in OBC category vide result Notices dated 15.10.15 and 14.01.16 selection, are hereby shifted to UR category:

In view of above 5 vacancies shall be created in OBC Category and 01 candidate who was selected vide Result Notice dated 28.07.2016 having Roll No. 13003676 (Saurabh Sharma) in UR category, shall become excess in UR category. Incidentally, the User Department had returned the dossiers of 04 candidates – having Roll number 13007774 (Rajat Malik); 13002209 (Manish Kharb); 13003634 (Sunil) and 13004713 (Mohd Imran) after cancellation of their candidatures. Out of the 04 dossiers returned 03 were from UR category. In the present circumstances, Board has adjusted the selection of the candidate having 13003676 (Saurabh Sharma) in UR Category, against the cancelled candidatures of UR category candidates.

Further, in view of available candidates in merit who had qualified the PET, after preliminary scrutiny of eligibility for the post as per provisions of the statutory Recruitment Rules and the terms and conditions of the advertisement, the following candidates, are hereby provisionally selected to the post of Assistant Superintendent in Delhi Prisons Department under postcode 38/13:

Further, candidatures of candidates having Roll number 13001601 in UR/EX category is still pending for want of documents.

The selection of the above 02 Candidates shall be further subject to the thorough verification of the candidature of the candidates by the User Department including the identity of the candidate. The candidature of the candidate is liable to be cancelled by the User Department, in case, candidate is found not fulfilling all the eligibility conditions of the Recruitment Rules of the post or for any other genuine reason. The decision of the User

by

Department/appointing authority regarding the eligibility of the candidate shall be the final and binding on the candidates.

The User department shall also check the eligibility of the reservation benefit, as per the reservation policy of the Government of NCT of Delhi. Further, User Department shall also verify the genuineness of the caste certificate furnished by the candidates prior to issuing offer of appointment to the candidates. The Competent Authority of the User Department shall arrange to verify the correctness/ genuineness of the information/ documents as furnished in the application form vis-à-vis the original documents. The appointing authority shall verify and satisfy itself about the authenticity of documents/certificates before finally appointing the candidate.

Further, the User Department shall arrange the checkup of selected candidates regarding any defect or deformity (including bow-legged, knock-kneed, flat feet etc) which will render candidate ineligible for recruitment, as per RRs of the post before issuing them an offer of appointment for the post.

Mere inclusion of the name of the candidate in the result notice does not confer any right upon the candidate over the post unless the appointing authority is satisfied after such inquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the post.

The selection of the above candidates is subject to the final outcome of the court matter having OA No 2761/2016 with MA 2477/2016 in Ld CAT in the matter of Deepak Mann & Ors Vs GNCTD & Ors; OA No 4312/2016 in Ld CAT in the matter of Pawan Vs GNCTD & Ors and OA No 35/2017 in Ld CAT in the matter of Kuldeep Kadyan Vs GNCTD & Ors.

While every care has been taken in preparing the result, DSSSB reserves the right to rectify errors and omissions, if any detected at any stage.
