The Competent Authority of the Department concerned shall issue the appointment letter to the candidates after satisfying themselves of their eligibility as laid down in the recruitment rules and on verification of the correctness of the information furnished in the application form and the documents related to Educational Qualification, Age, Caste Certificate and other Certificates, if any, seeking any relaxation in the eligibility standards. While getting the Caste Certificates verified from the issuing authority, it should be invariably ensured that the candidates claiming benefit under OBC category do not fall under creamy layer as per the latest instructions of the Govt. of India in this regard. It is further clarified that the eligibility regarding knowledge of Hindi/ working knowledge of Hindi has not been checked by the DSSSB due to late instructions issued in this regard by the User Department and the same, therefore, should be ensured by the User Department before issuance of appointment letter.

Further, roll no. mentioned at SI. No. 2 & 7 in UR category above & roll No. mentioned at SI. No. 5 & 6 in OBC category above stand deleted from the result notice no. 38 dated 24/06/2016 and roll no. mentioned at SI. No. 5 in UR category above also stand deleted from SC list from the result notice no. 08 dated 05/05/2016.
