## TELEPHONE OPERATOR, POST CODE-87/14 IN HEALTH & FAMILY WELFARE DEPARTMENT

The DSSSB vide its advertisement No. 01/14 had advertised 12 (UR-01, OBC-07, SC-02, ST-02 including 01 ExSM) vacancies for the post of Telephone Operator in Health & Family Welfare Department under Post Code-87/14. Tier-I online examination was held on 06.11.2019.

- 2. All 105 candidates who had appeared in written examination were informed through notice No. F. No. 235/Result/Telephone Operator/Int. Cell/DSSSB/2019-20/1444-52 dated 05/06/2020 on the Board's website i.e. <a href="www.dsssb.delhi.gov.in">www.dsssb.delhi.gov.in</a> that their marks for the examination dated 06.11.2019 for the post of Telephone Operator, Post Code-87/14 have been declared and the same were available in their account in OARS module. Further, vide said notice, 06 shortlisted candidates who qualified the written examination were given the opportunity to upload their documents in the e-dossier module w.e.f. 12.06.2020 to 26.06.2020 with the specific direction that if any candidate fails to upload the e-dossier during the above said period, his/her candidature will be rejected and no further opportunity for uploading e-dossier will be given on whatsoever ground. The shortlisted candidate has uploaded his documents in the e-dossier portal.
- 3. On the basis of marks secured in the written examination and after preliminary scrutiny as per the provisions of the statutory Recruitment Rules for the post and the terms and condition of the advertisement, the following 02 Candidate under SC category are provisionally selected for the post of Telephone Operator, Post Code-87/14 in Health & Family Welfare Department subject to their fulfilling all other conditions of eligibility and also correctness of the information furnished by the candidates in their online application form and e-dossier:-

O/o the Divisional Engineer (Phones), New Telephone Exchange that the candidate being 2<sup>nd</sup> year student of B. Tech. (Electronics & Communications) at IIT Ghaziabad has been imparted vocational Training in pursuance of the CGMT, Bihar Circle, Patna for the period of 03 weeks starting from 02.07.2007. On the basis of B.Tech. (Electronics & Communications) & certificate from Bharat Sanchar Nigam Ltd., the candidate is being provisionally nominated subject to the satisfaction of the user department regarding essential educational qualification before issuance of appointment letter. The user department is further requested that if the candidate found not eligible, his dossier may be returned after cancellation of his candidature.

- 4. The selection of the above 02 candidates shall further be subject to genuineness of the documents on the basis of which they have claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of advertisement inviting applications and subject to thorough verification of their identity with reference to their photographs, signatures/handwriting etc. on the application form, admission certificate etc. The candidature of the above candidates are liable to be cancelled by the User Department also, in case the candidates are found not to be fulfilling the terms & conditions of the advertisement inviting applications for the said post code. The Competent Authority of the Department concerned shall issue the appointment letter to the candidates after being satisfied about their eligibility as down in the recruitment rules and after verification of the correctness of the information furnished in the application form and the documents related to Educational Qualification, Age and other essential certificates.
- 5. The user department shall also check the eligibility of the reservation benefit, if any. Further, if applicable, the User Department shall verify the genuineness of the Caste Certificates furnished by the candidate prior to issuing offer of appointment to the candidate. The Competent Authority of the user department shall arrange to verify the correctness of the information/documents as furnished in the e-dossier vis-à-vis the original documents. User Department is requested to ascertain the scrutiny /correctness of the same at their own level before issuing the offer of appointment to the provisionally selected candidates. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates and essential qualification for the post before finally appointing the candidate. The User Department is also requested to rectify/correct, in case, any minor/clerical error/deficiency noticed in the documents of the candidate at their own level.
- 6. It is stated that the User Department shall verify the genuineness of the caste certificate furnished by the candidate in the light of Notification No. 36012/22-93-Estt. (SCT) dated 08/09/1993 issued by DOPT and other instructions/guidelines issued from time to time by the Competent Authority prior to issuance of offer of appointment to the candidate. It is further stated that, prior to appointment, the User Department must satisfy, itself, that the above candidates are fulfilling the necessary criteria as prescribed for entitlement of OBC (Delhi) certificate as specified in various Orders/Guidelines/Circulars including order dated 07/03/2017 issued by Revenue Department, GNCTD after thorough verification of caste certificate.
- 7. The User Department shall also get the SC/ST/OBC/PH/ExSM/etc. certificates verified from the Issuing authority. Further, if applicable, User Department shall also verify the genuineness of the caste certificates furnished by the candidates prior to issuing offer of appointment to the candidates. In case of the OBC candidates, it may also be verified that the candidate does not belong to creamy layer of the schedule of Govt. of India, DoPT O.M. No. 36012/22/93-Estt. (SCT) dated 08.09.1993, O.M. No. 36033/3/2004-Estt. (Res) dated 09.03.2004 and 14.10.2009 and O.M. No. 36033/1/2013-Estt. (Res) dated 27.05.2013 & 13.09.2017.
- 8. The Competent Authority of the Department concerned shall issue the appointment letters to the candidates after being satisfied about his eligibility as laid down in the

recruitment rules and after verification of the correctness of the information/documents as furnished in the application form and e-dossier vis-à-vis the original documents related to Educational Qualification, Age and other essential Certificates as per instructions issued by Govt. of India in this regard vide MHA O.M. No. 2/29/54-RPS, 19-11-54.

- The user department shall ensure that the appointment made is in conformity with DoPT guidelines and instructions of Govt. issued from time to time.
- 10. The result process for the above post code stands closed in all respect.
- 11. There is no waiting panel prepared as no qualified/suitable candidate available in the merit.
- 12. Mere inclusion of name of candidate in the result notice does not confer any right upon the candidate over the post unless the appointing authority is satisfied after such enquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the Post.
