RESULT NOTICE NO.746
Fireman (Band) under post code 56/15, in Delhi Fire Service.

1. The DSSSB vide its advertisement No. 01/2015 with closing date 26/11/2015, had advertised **26 vacancies (UR-13, OBC-07, SC-04 & ST-02 including EXSM-03)** for the post of Fireman (Band) in Delhi Fire Service. The Board had conducted One Tier written examination for recruitment to this post on 14.05.2017.
2. The marks obtained by 51 candidates who appeared in the said examination are hereby notified in query based marks display system on the website of DSSSB.
3. Further, based on the performance in One Tier written examination, **37 (Thirty seven) candidates (UR-24, OBC-05, SC-06 & 02 UREXSM)** were provisionally shortlisted to appear in the Physical Endurance Test which was held on 18/09/2018.
4. Further, vide result notice No. 739 dated 07.12.2018, total 05 candidates were called for uploading the e-dossier. The e-dossier link was activated w.e.f 13.12.2018 to 27.12.2018. Total 05 candidates have uploaded the documents through e-dossier module in stipulated time.
5. It is stated that as per RRs one of essential qualification is " 02 Years experience in band contingent in a recognized organization". Further, since, 02 Years experience in band contingent in a recognized organization is a subjective and technical matter and User department has not provided any specification in this regard, therefore, at this stage, DSSSB has not undertaken the veracity/scrutiny of experience certificate furnished by the candidates as such User Department i.e. DFS is requested to ascertain the Scrutiny/correctness of the same at their own level before issuing the offer of appointment to the proposed candidates.
6. On the basis of marks secured in written examination and after preliminary scrutiny as per the provisions of the statutory Recruitment Rules for the post and the terms and conditions of the advertisement, the following candidate is provisionally selected to the post of Fireman (Band) under post code 56/15, in DFS subject to their fulfilling all other conditions of eligibility and also correctness of the information furnished by the candidates in their online application form and e-dossier:-

9. No candidate found suitable in SC, ST & EXSM category.

10. The provisional selection of the above **05 candidates (UR-04 & OBC-01)** is based on submission of photocopy of documents related to age, qualification & caste certificate etc. & original of same have not been seen/verified by DSSSB shall further be subject to through verification and fulfilment of all the eligibility conditions as prescribed and the terms and condition of advertisement for the said post. The candidatures of the candidates are liable to be cancelled by the User Department also, in case the candidate is found not to be fulfilling the eligibility conditions or due to any other genuine reason. The decision of the User Department i.e. DFS regarding the eligibility of the candidate shall be final and binding on the candidate.

11. The User Department shall also check the eligibility of the reservation benefit, if any. Further, if applicable, User Department shall verify the genuineness of the caste certificate furnished by the candidate prior to issuing offer of appointment to the candidates. The Competent Authority of the User Department shall arrange to verify the correctness of the dossier vis-a-vis the original documents. **DSSSB has not undertaken the veracity/scrutiny of experience certificate furnished by the candidate as such user department i.e. DFS is requested to ascertain the scrutiny/correctness of the same at their own level before issuing the offer of appointment to the above provisionally selected candidate. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates and essential qualification regarding successful completion of training for the post before appointing the candidate.**

12. The User department i.e. DFS shall also get the SC/ST/OBC certificates verified from the issuing authority before his/her appointment. Further, in case of the OBC candidates, it may also be verified that the candidate does not belongs to creamy layer of the schedule of Govt. Of India, DOPT O.M. No. 36012/22/93-Estt.(SCT) dated 08.09.1993 O.M. No. 36033/3/2004-Estt. (Res) dated 09.03.2004 and O.M. No. 36033/3/2004-Estt. (Res) dated 14.08.2008.

13. Mere inclusion of the name of the candidate in the result notice does not confer any right upon the candidate over the post unless the User Department i.e. DFS is satisfied after such inquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the post.

14. The above result is subject to outcome of the O.A. No. 100/3552/2018.

15. While every care has been taken in preparing the results, the DSSSB reserves the right to rectify errors and omissions, if any.
