- 1. The DSSSB vide its advertisement No. **01/2010** with closing date **15.03.2010**, had advertised **149 vacancies** (UR-72, OBC-31, SC-21, ST-25 including OH-01, VH-01 & HH-92) for the post of TGT (SST), Female in Directorate of Education under post code 10/10.
- 2. The DSSSB as per result notice No. 413 dated **18.07.2016**, while declaring the result of above post code, has kept result of 68 candidates in pending list for want of additional documents, thereafter further selection was made vide result notice No. 463 dated 06.01.2017 and result notice No. 531 dated 10.07.2017. The candidature of candidates who did not respond was cancelled vide result notice dated 10.07.2017. As the validity of the waitlist panel was valid up to 17.07.2017, the Board is declaring the result of the candidate from the waitlist panel. After preliminary scrutiny of eligibility for the post as per provisions of statutory RRs and the terms & conditions of the advertisement the following candidate is provisionally selected to the post of TGT (SST) Female, post code 10/10 in Directorate of Education in the Pay Scale of Rs. 5500-175-9000 (Pre-revised).

- 4. The selection to the above **01** candidate in SC category shall be further subject to the thorough verification of the candidature of the candidate by the User Department including the identity of the candidate.
- 5. The candidature of the candidate is liable to be cancelled by the User Department, in case, candidate is found not fulfilling all the eligibility conditions of the Recruitment Rules for the post or any other genuine reason. The decision of the user department/ appointing authority regarding the eligibility of the candidate shall be the final and binding on the candidate.
- 6. The Competent Authority of the user department shall arrange to verify the correctness of the information/ documents as furnished in application forms vis-à-vis the original documents including the educational qualification. Further, the appointing authority shall verify these documents and satisfy itself about the authenticity of documents/ certificates before finally appointing the candidate.
- 7. The Competent Authority of the Department concerned shall issue the appointment letter to the candidates after being satisfied about their eligibility as laid down in the recruitment rules and after verification of the correctness of the information / documents as furnished in the application form and e-dossier vis-à-vis the original documents related to education qualification, age and other essential

certificate as per instructions issued by Govt. of India vide MHA OM No. 2/29/54-RRs19-11-54.

- 8. The User Department shall also get the SC certificates verified from the issuing authority before his /her appointment.
- 9. The User Department shall ensure that the appointment made is in conformity with DOPT guidelines and instructions of Govt. issued from time to time.
- 10. Mere inclusion of the name of the candidate in the result notice does not confer any right upon the candidate over the post unless the appointing authority is satisfied after such inquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the post.
- 11. The recruitment process for the post of TGT (SST) Female under post code 10/10 stands closed in all respect.
- 12. Further waitlist panel for the post code 10/10 stands expired on 18.07.2017 i.e. after one year from the date of declaration of result on 18.07.2016
- 13. The category-wise marks scored by the last candidate provisionally nominated are as under:-
