## NOTICE NO. 967 WILD LIFE INSPECTOR (POST CODE 67/14) IN FOREST AND WILD LIFE DEPARTMENT

- 1. The DSSSB vide its Advertisement No. 01/14 with closing date 27/02/2014 had advertised 02 vacancies (UR-01, OBC-01) for the post of Wild Life Inspector in Forest and Wild Life Department under Post Code 67/14.
- 2. Board Conducted Tier-I written examination for recruitment in respect of this post on 20/11/2019.
- 3. The marks obtained by **51** candidates who have duly appeared in written examination (online mode in single shifts) held on **20/11/2019** have been uploaded on Board's website. Candidate can view their marks by logging into their account in the OARS Module <a href="https://www.dsssbonline.nic.in">www.dsssbonline.nic.in</a>
- 4. Based on the performance in Tier-I written examination (online mode), out of these 51 candidates, 16 (Sixteen) candidates, who obtained marks above or equal to cut off marks in their respective categories, as detailed below, have been provisionally shortlisted to appear in Tier-II examination subject to correctness of the information furnished by the candidates in their online application forms. The shortlisted candidates shall be called for Tier II examination separately.

- 5. Only those candidates have been considered in OBC Category who have declared that they are OBC (Delhi) in their online application form
- 6. Further since documents have not been called from the candidates along with the online application forms as such detailed scrutiny regarding eligibility has not been carried out, and therefore, mere inclusion of names in the list of candidates shortlisting for appearing in Tier II examination does not entitled them any right over the post.
- 7. Reserved Category candidates who have obtained marks above or equal to the last shortlisted UR Candidates have been shortlisted against UR vacancies and their final selection to the post shall be considered in UR category, subject to availability of vacancies, otherwise for selection in their respective category.
- 8. Further all the candidates who have scored marks equal to the cut off marks in each category have also been shortlisted for Tier II examination.
- 9. As per the Board Notice dated 26/04/2013 the minimum qualifying marks in Two Tier written examinations for UR Category Candidate is 40%, for OBC Candidate is 35%.

- 10. The details of Tier II examination shall be notified separately by the Board. The candidates are hereby advised to check the website of the Board regularly.
- 11. The above shortlisting for Tier II examination for the post of wildlife Inspector in the post code 67/14 in Forest & Wild Life Department, GNCTD will be subject to outcome of pending court cases, if any.
- 12. While every care has been taken in preparing the result, DSSSB reserves the right to rectify errors and omissions, if any detected at any stage.
