WARDER (MALE) IN DELHI PRISONS DEPARTEMNT (POST CODE-37/13)

- 1. The DSSSB vide its advertisement No. 02/2013 with closing date 02.08.2013, had advertised 528 vacancies (UR-268, OBC-142, SC-79, ST-39 out of which 53 vacancies were reserved for EXSM) for the post of Warder (Male) in Delhi Prisons Department.
- 2. The Board had conducted the written examination on 02.03.2014 for the post of Warder (Male) under postcode 37/13. On the basis of the written examination the candidates were shortlisted to appear for PET, which was qualifying in nature. After conducting the Physical Endurance test (PET-I & PET-II) in respect of shortlisted candidates from 16.03.2015 to 22.03.2015 and also from 01.07.2016 to 09.07.2016 & 06.05.2017, 414 candidates who qualified the PET were nominated to the post of Warder (Male) under post code 37/13 vide result notice No. 357 dated 29.12.15 and subsequent result notice No. 381 dated 07.03.2016, result notice No. 382 dated 13.04.2016, result notice No. 471 dated 15.2.17 and result notice No. 523 dated 27.6.2017.
- 3. In view of the request of the user department vide letter No. F.18(314)/Estt./PHQ/CJ/2012/CD-8389/3112-14 dated 14.06.2017 and for filling the unfilled vacancies, 1416 candidates were shortlisted for appearing in PET-III for the post vide notice number 535 dated 22.08.2017.
- 4. The PET-III was conducted from 12.02.2018 to 16.02.2018 wherein 489 candidates appeared for the test out of which only 132 candidates could qualify the PET. The result status of PET-III was declared vide notice number 653 dated 21.05.2018. The candidature of candidate having roll number 13007595,13029611 and 13049618 are withheld for further examination.
- 5. Simultaneously, 231 candidates who have qualified the PET-III and whose cases were pending or not considered for selection earlier due to lower merit were provisionally shortlisted to upload their documents in e-dossiers from

23.05.2018 to 06.06.2018, the e-dossier link was further extended upto 13.06.2018.

- 6. The e-dossier link of 06 candidates having roll number 13008112, 13013479, 13041169, 13019749, 13011156 and 13044479 could not been opened so far due to technical problem as a result their candidature are still pending.
- 7. Ld CAT vide its interim order dated 07.04.2015 in OA No1294/15 in the matter of Varun Sharma vs GNCTD has directed to keep one post under as pending, accordingly one post of UR category is kept as pending.
- 8. After preliminary scrutiny of the candidature of candidates as per the provisions of the statutory Recruitment Rules for the post in respect of the educational qualification and the terms and conditions of the advertisement on qualifying the PET, the following candidates are provisionally selected to the post of Warder(Male) subject to satisfaction in regard to any defect or deformity (including bow legged, knocked knees, flat feet etc.) which would render candidate ineligible for recruitment as per the requirement of the RRs:

- 16. The selection of the above 146 Candidates shall be further subject to the thorough verification of the candidature of the candidate by the User Department including the identity of the candidate. Further the user department shall arrange for checking of defect or deformity (including bow legged, knocked knees, flat feet etc.) of the candidates as per the requirement of the RRs, which has not been done during PET-III.
- 17. The candidature of the candidate is liable to be cancelled by the User Department, in case candidate is found not fulfilling all the eligibility conditions of the Recruitment Rules of the post or any other genuine reason. The decision of the User Department/appointing authority regarding the eligibility of the candidate shall be the final and binding on the candidate.



- 18. The User department shall check the eligibility of the reservation benefit, if any. Further, if applicable User Department shall verify the genuineness of the caste certificate furnished by the candidate prior to issuing offer of appointment to the candidates.
- 19. The Competent Authority of the User Department shall arrange to verify the correctness of the information/ documents as furnished in the application forms vis-à-vis the original documents including the Degree. Further, the appointing authority shall verify these documents and satisfy itself about the authenticity of documents/certificates before finally appointing the candidates.
- 20. Mere inclusion of the name of the candidate in the result notice does not confer any right upon the candidate over the post unless the appointing authority is satisfied after such inquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the post.

- 24. The selection of the candidates are subject to the outcome of the court order in the matter of Vinay Mann Vs GNCTD in OA number 2284/16.
