SUPPLEMENTARY RESULT NOTICE: 56 ASSISTANT TEACHER (NURSERY) UNDER POST CODE- 03/13 DIRECTORATE OF EDUCATION, GNCTD.

- 01. In compliance of order dated 10.10.2023 passed by Ld. CAT of Delhi in OA No. 472/2019 in the matter of Nisha Versus Govt. of NCT of Delhi & ORS., passed by Ld. CAT, it has been directed as follows:
 - "6.1...Accordingly, we allow the Original Application and the impugned Supplementary Result Notice dated 26.03.2018 is quashed and set aside to the extent it relates to the applicant. As a corollary, the applicant is held to be entitled for appointment to the post of Assistant Teacher (Nursery) against post code 03/13, subject to fulfilling other criteria and meeting requisite terms & conditions governing such an appointment. She shall also be entitled to all consequential benefits flowing therefrom from the date her immediate junior in the merit list had been given appointment. However, these benefits shall be on a notional basis till the date she actually joins the post; and on actual basis thereafter. The consequential benefits on a notional basis so awarded shall include, but will not be restricted to, fixation of appropriate pay and allowances, including increments and promotions from time to time subject to her being found eligible and suitable for the same.
 - 6.2. The exercise, as ordained above, shall be completed by the competent authority amongst the respondents, within a period of eight weeks from the date of receipt of a certified copy of this Order".
- **02.** DSSSB vide Advertisement No. 01/13 had advertised 445 vacancies (UR-221, OBC-123, SC-66, ST-35, including PH(OH)-07 VHVI-06) for Assistant Teacher (Nursery) under post code 03/13 in GNCTD.
- **03.** It is informed that the applicant Ms. Nisha the petitioner herein had applied for the above mentioned post code 03/13 in OBC Category. The Board issued Roll No. 68000516 and she has appeared in the written examination which was held on 31.08.2014. She scored 93.25 marks in the said examination.
- O4. On scrutiny of record provided by the candidate, it was found that the candidate belongs to OBC (Outsider) not OBC (Delhi). Her candidature was not considered as OBC (Delhi) being OBC Outsider/other than Delhi.
- **05.** The main Result for the post has been declared on 13.01.2016 which was revised vide Result Notice dated 07.03.2017. The Recruitment process for the said post has already been closed and Unfilled vacancies returned to User Department vide letter dated 04.09.2018, the waiting panel has also been expired.
- **06.** Thereafter Ms. Nisha approached the Hon'ble CAT vide OA no. 472/2019. The Hon'ble CAT vide order dated 10.10.2023 allowed the OA as stated above.
- 07. Being aggrieved, the Board has approached Hon'ble High Court of Delhi vide WPC No. 373/2024 in the matter of Govt. of NCT of Delhi & ORS VS. Nisha.
- **08.** Candidate has also filed a contempt Petition i.e. CP No. 239/2024 in O.A. No. 472/2019 in the matter of Nisha Vs. Sh. Naresh Kumar, Chief Secretary, Delhi and others. The Ld. CAT vide order dt. 14.10.2024 has directed as follows:

- "4. Be that as it may, last and final opportunity is granted to the respondents to file compliance affidavit within three weeks, failing which respondent no.2 shall appear in person on the last date of hearing."
- **09.** Therefore, in compliance of 10.10.2023 passed by Ld. CAT of Delhi in OA No 472/2019 in the matter of Nisha Vs. Govt. of NCT of Delhi & ORS., passed by Ld. CAT, the following one (01) candidate is provisionally nominated as under:

- 10. The provisionally nomination of the above 01 (One) candidate (OBC-01) has been processed purely on the basis of marks obtained by the candidates in the examination held on Offline Exam conducted on 31.08.2014 and also claims made by the candidates in their offline application forms of the post code 03/13 for the post of Assistant Teacher (Nursery) in Directorate of Education. The eligibility as per Recruitment Rules and other terms and conditions as specified in the advertisement no. 01/13 and relaxations as per rules in respect of educational qualifications, experience, etc. shall be scrutinized/verified by the User Department for determining eligibility of the candidate for the post code 03/13 as on cut-off date 20.03.2013 before issuance of offer of appointment to the post and in accordance compliance of the order dated 10.10.2023 passed by Ld. CAT of Delhi in OA No. 472/2019 in the matter of Nisha Versus Govt. of NCT of Delhi & ORS., passed by Ld. CAT.
- 11. The User department shall also check the eligibility of the reservation benefit, if any. Further, if applicable, User Department shall verify the genuineness of the caste certificate furnished by the candidate prior to issuing offer of appointment to the candidates. The Competent Authority of the User Department shall arrange to verify the correctness of the information/ documents as furnished in the dossier vis-à-vis the original documents. User Department is requested to ascertain the scrutiny/correctness of the same at their own level before issuing the offer of appointment to the provisionally selected candidates. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates and essential qualification for the post before finally appointing the candidate. The User Department is also requested to rectify/correct, in case, any minor/clerical error/deficiency noticed in the documents of the candidate at their own level.
- **12.** The category wise marks scored by the last provisionally nominated is as under:

- **13.** The User Department, being Cadre Controlling/Appointing Authority, shall strictly follow the merit based ranking of the candidate.

- 15. The User department shall ensure that the appointment made is in conformity with DOPT guidelines and instructions of Govt. issued from time to time.
