The DSSSB vide its advertisement No 01/2014 with closing date 27/02/2014, had advertised 99 vacancies (UR-53, OBC-02, SC-16, ST-08 including 04 EXSM) for the post of Assistant (OT/CSSD) in Health & Family Welfare Department under post code 35/14 in the pay scale of Rs. 5200-20200/- with grade pay 1900/-. The Board had conducted screening test on 25.05.2014 and shortlisted 23 candidates for appearing for Interview. Interview for the post was held on 11.03.2015. On the basis of the marks scored by the candidates in Academic qualification Assessment and Interview, merit list has been prepared. After preliminary scrutiny of eligibility for the post as per the provisions of the statutory Recruitment Rules and terms and conditions of the advertisement, the following candidates are provisionally selected to the Assistant (OT/CSSD) in Health & Family Welfare Department under post code 35/14:

The candidature of candidates having Roll No 12002679 and 12005887 are pending in UR and SC category respectively for want of clarification from user department regarding admissibility of Diploma in Anesthesia for the post.

The candidature of candidate having Roll No 12005585 is pending in SC category for want of clarification from user department regarding admissibility of age relaxation to contractual employees working in medical institution of MCD.

Further, candidatures of candidate having Roll No 12006098 has been kept pending in UR for want of details of acquiring the Diploma, accordingly the candidate is hereby directed to furnish the requisite document latest by 15.05.2017.

The candidature of candidate having Roll Number 12002612 who was provisionally shortlisted for Interview in OBC Category is rejected, as he had furnished OBC Certificate issued made on the basis of his father's OBC (UP) certificate, which is not admissible for seeking OBC reservation benefit in Delhi. Further, candidature of candidate having Roll number 12002582 is rejected as he could not qualify the Interview.

The selection of the above 13 Candidates shall be further subject to the thorough verification of the candidature of the candidate by the User Department including the identity of the candidate. The candidature of the candidate is liable to be cancelled by the User Department, in case, candidate is found not fulfilling all the eligibility conditions of the Recruitment Rules of the post or any other genuine reason. The decision of the User Department/appointing authority regarding the eligibility of the candidate shall be the final and binding on the DSSSB and the candidate.





The User department shall also check the eligibility of the reservation benefit, if any, as per the reservation policy of the Government of NCT of Delhi. Further, User Department shall verify the genuineness of the caste certificate furnished by the candidate prior to issuing offer of appointment to the candidate, if applicable. The Competent Authority of the User Department shall arrange to verify the correctness of the information/ documents as furnished in the application form vis-à-vis the original documents. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates before finally appointing the candidate.

Mere inclusion of the name of the candidate in the result notice does not confer any right upon the candidate over the post unless the appointing authority is satisfied after such inquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the post.
