The candidates mentioned at S.No.1 & 2 under UR Category and the candidate mentioned at S.No.2 under SC category has already been nominated under Post Code 11/13. Similarly, the candidate mentioned at S.No.3 under UR Category has been shifted from OBC Category to UR Category on the basis of her merit on account of lowering of merit. These candidates may now on be treated as nominated under the categories as mentioned above.

Further, their nomination under the relevant categories as already mentioned on the corresponding result notice be stand shifted for the purpose of updating the result as per their merit.

The selection of the above candidates shall further be subject to genuineness of the documents on the basis of which they have claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of advertisement, inviting applications and subject to thorough verification of their identity with reference to their photographs, signatures/handwriting etc. on the application form, admission certificate etc. The candidature of the above candidates are liable to be cancelled by the User Department, in case the candidates are found not to be fulfilling the terms & conditions of the advertisement inviting applications for the said post code. The Competent Authority of the Department concerned shall issue the appointment letter to the candidates after satisfying himself of their eligibility as laid down in the recruitment rules and on verification of the correctness of the information furnished in the application form and the documents related to Educational Qualification, Age, Caste Certificate and other Certificates, if any, seeking any relaxation in the eligibility standards. It is further clarified that the eligibility regarding knowledge of Hindi/ working knowledge of Hindi has not been checked by the DSSSB due to late instructions issued in this regard by the User Department and the same, therefore, should be ensured by the User Department before issuance of appointment letter.

Further, Roll No. 49000962 mentioned at SI. No. 01 in OBC category stands deleted from the Result Notice No. 13 dated 16/05/2016 from OBC list due to shifting of her candidature from OBC category to UR category as per own merit in UR category.

Mere inclusion of name in the result notice does not confer any right upon the candidate over the post.
