The selection of the above candidate shall further be subject to genuineness of the documents on the basis of which he has claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of advertisement inviting applications and subject to thorough verification of his identity with reference to his photographs, signatures/handwriting etc. on the application form, admission certificate etc. The candidature of the above candidate is liable to be cancelled by the User Department also, in case the candidate is found not to be fulfilling the provisions of Recruitment Rules and the terms & conditions of the advertisement inviting applications for the said post code. The Competent Authority of the Department concerned shall issue the appointment letter to the candidate after satisfying himself of his eligibility as laid down in the recruitment rules and on verification of the correctness of the information furnished in the application form and the documents related to Educational Qualification, Age, Caste Certificate and other Certificates, if any, seeking any relaxation in the eligibility standards. While getting the Caste Certificates verified from the issuing authority, it should be invariably ensured that the candidate claiming benefit under OBC category do not fall under creamy layer as per the latest instructions of the Govt. of India in this regard. It is further clarified that the eligibility regarding knowledge of Hindi/ working knowledge of Hindi has not been checked by the DSSSB due to late instructions issued in this regard by the User Department and the same, therefore, should be ensured by the User Department before issuance of appointment letter.

The candidature of the above candidate was earlier rejected vide rejection notice no. 48 dated 27/07/2016 for not providing OBC (Delhi) certificate. As the candidate has provided OBC



(Delhi) certificate prior to the cutoff date, his candidature has now been revived with the approval of the Competent Authority.

It is further highlighted that as per the order of the Central Administrative Tribunal dated 22.12.2015 in the matter of Ashish Yadav Vs DSSSB in O.A. No.4631/2016, order dated 01.04.2016 in the matter of Dinesh Kumar Vs Govt. of NCT of Delhi in O.A. No. 1222/2016 and order dated 08.09.2016 in the matter of Pramod Kumar Vs. DSSSB in O.A. No. 100/3067/2016, appointments, if any, made by respondents will be subject to the outcome of the above said O.A.

Mere inclusion of name in the result notice does not confer any right upon the candidate over the post.
