1. The DSSSB vide its advertisement No. 01/2015 had advertised 05 vacancies (UR-03, OBC-02) for the post of Statistician under post code 39/15, in SCERT with closing date 26.11.2015. One tier written examination was conducted on 14.05.2017 wherein 264 candidates appeared.
2. The marks obtained by 262 candidates who have appeared in written examination have been uploaded on Board's website. Candidates can view their marks by logging into their account in OARS module on www.dsssonline.nic.in.
3. OMRs of candidate having roll number 13200143 and 13200515 were not evaluated as candidates had not correctly bubbled their roll number in the relevant space/column; accordingly their candidature is hereby cancelled.
4. Based on the performance in the examination, candidates, as detailed below, have been provisionally allowed to upload e-dossiers subject to attaining minimum qualifying marks and correctness of the information furnished by the candidates in their online application forms.
