ORDER

Compliance of order/direction dated 20.05.2014 of the Hon'ble Central Administrative Tribunal as passed in OA 510/2013 titled as Ms. Neelam Kumari V/s GNCTD & Ors.

The Hon'ble CAT in OA 510/2013, titled as Ms Neelam Kumari V/s GNCTD & ors. Vide its order dated 20.05.14 has directed as under:-

" In view of the foregoing discussions and reasons given, we allow this OA and direct the respondents to consider the candidature of the applicant as having passed MA (Final) Hindi prior to the last date of submission of the application form after satisfying themselves about the authenticity of the pass provisional slip issued by Kurukshetra University, Kurukshetra. No order as to costs."

In compliance of above order, the case of applicant i.e. Ms Neelam Kumari, Roll No.02412228 has been re examined and it is hereby decided that:-

1. Whereas, the applicant Ms. Neelam Kumari had applied for the post of PGT (Hindi)(Female) under post code No.24/10.
2. Whereas, the DSSSB had conducted the examination for this post PGT (Hindi) under post code No.24/10 on 10.12.2011 and the result was declared on 22.8.2012.
3. Whereas, the applicant Ms Neelam Kumari appeared in OBC category & was short listed in part-I examination in General category.
4. Whereas, the candidate obtained 100/200 marks as per final merit list and her result was kept pending for completion of documents vide Result Notice No.78 dated 22.08.2012.
5. Whereas, thereafter, the documents furnished by the candidate were scrutinized and it was observed that the applicant has passed MA (Hindi) Final examination in May-2011 i.e. after the cut-off date (30.07.2010). Accordingly she was not found eligible for selection to the post of PGT (Hindi) under the post code-24/10 in Govt. of NCT of Delhi.
6. Whereas, candidature of the applicant was rejected vide DSSSB Rejection Notice No.203 dated 16.01.2013 for the post of PGT (Hindi) under the post code-24/10.
7. Whereas, Ms. Neelam Kumari filed OA No.510/2013 before Hon'ble CAT.
8. Whereas, in compliance of order/direction dated 20.05.2014 of the Hon'ble Central Administrative Tribunal as passed in OA 510/2013, Board had requested to provide the clarification from Kurukshetra University vide letter dated 14.01.2015.

9. Whereas, Kurukshetra University asked to provide the DMC Sr.No.72536 issued to Ms.Neelam Kumari for further action in the matter.
10. Whereas, Ms.Neelam Kumari was issued letter dated 14.01.2015 to take necessary action as instructed by the Kurukshetra University in their letter dated 19.08.2014.
11. Whereas, Kurukshetra University has furnished requisite information **that Ms.Neelam Kumari has passed MA (Hindi) Final in May-2011 and obtained her degree in May-2011 (i.e. after the cutoff date 30.07.2010)** and whereas her earlier result for MA (Hindi) Final examination under Roll No.877947 bearing DMC Sr.No.72536 was got cancelled.
12. Whereas, the applicant did not possess the requisite essential eligibility criteria on the declared cutoff date i.e. 30.07.2010, hence she is not eligible for selection to the post of PGT (Hindi).

In view of the above facts, the applicant Ms. Neelam Kumari cannot be considered for selection to the post of PGT (Hindi)) under post Code 24/10. The claim of the applicant cannot be considered.
