POST GRADUATE TEACHER (ENGLISH) (FEMALE) IN DIRECTORATE OF EDUCATION UNDER POST CODE 133/2012

The DSSSB vide Result Notice No 448 dated 17.10.2016 had declared the result of 36 candidates for the post of *Post Graduate Teacher (English)* (Female) in Directorate of Education under **Post code 133/2012**.

The candidature of candidate having Roll No. 33000902 and 33004353 was kept pending in Result notice dated 17.10.2016 on account of Court Case filed by the candidate in Ld CAT having OA 4233/14 and OA No. 2239/15 respectively. Ld CAT vide order dated 19.10.2016 in OA No.2239/15 in the matter of Alka Vs DSSSB & Ors has dismissed the OA. Further, Ld CAT vide order dated 05.10.2016 in OA No.4233/14 in the matter of Meenu Bhati & Ors vs GNCTD has allowed the OA wherein Ms Mamta Sharma was applicant No 2. Accordingly, The candidature of Ms Mamta Sharma has been examined for the postcode 133/2012, however since Ms Mamta Sharma (33004783) had scored 98.5 marks in Tier –II Exam, which were less than the marks of last candidate in zone of consideration/selected candidate for the post of PGT (English) under postcode 133/12, as such her candidature was not be considered for the selection under postcode 133/12.

Further, the candidature of candidate having Roll number 33000634 was kept pending in UR category for clarification from concerned department for eligibility of age relaxation to the candidate. Services Department Vide their letter No F.2 (Misc)/RR/2003/S-IV/1980 dated 20.12.2016 has adviced to refer to para 3 of DOPT OM No 15012/2/2010-Estt.(D) dated 27.3.2012. In para 3 of said OM it has been clarified that age relaxation as admissible to Government employees is not applicable to personnel working in autonomous/statutory bodies, accordingly said age relaxation is not admissible to the candidate Seema Kapoor (33000634) who is working in SDMC, and therefore her candidate is rejected being overage in UR Category.

In view of above and on the basis of the merit list of Tier- II examination and after preliminary scrutiny of eligibility for the post as per the provisions of the statutory Recruitment Rules of the post and the terms and conditions of the advertisement, the following candidates are

The Competent Authority of the User Department shall arrange also verify the correctness and authenticity of the information/documents as furnished in the application form vis-à-vis the original documents before finally appointing the candidate.

Mere inclusion of the name of the candidate in the result notice does not confer any right upon the candidate over the post unless the appointing authority is satisfied after such inquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the post.
