The selection of the above candidates shall further be subject to genuineness of the documents on the basis of which they have claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of advertisement, inviting applications and subject to thorough verification of their identity with reference to their photographs, signatures/handwriting etc. on the application form, admission certificate etc. The candidature of the above candidates is liable to be cancelled by the User Department, in case the candidates are found not to be fulfilling the terms & conditions of the advertisement inviting applications for the said post code. The Competent Authority of the Department concerned shall issue the appointment letters to the candidates after satisfying himself of their eligibility as laid down in the recruitment rules and on verification of the correctness of the information furnished in the application form and the documents related to Educational Qualification, Age, Caste Certificate and other Certificates, if any, seeking any relaxation in the eligibility standards. It is further clarified that the eligibility regarding knowledge of Hindi/ working knowledge of Hindi has not been checked by the DSSSB due to late instructions issued in this regard by the User Department and therefore appropriate action in this regard may be taken by the User Department before issuance of appointment letter.

Further, the candidate whose roll No. find place at Sl. No. 1 above stand deleted from the result notice no. 51 dated 01/08/2016 due to shifting of this candidate from Post Code-14/13 to Post Code-116/12 as per his merit. Further the candidates whose roll nos. find place at Sl. No. 2, 5, 6 & 7 in this notice were earlier nominated vide result notice no. 27 dated 10/06/2016 in reserved categories. The result notice no. 27 dated 10/06/2016 stand modified so as to shift these candidates from selection against reserved vacancies in corresponding categories to the vacancies under UR quota as these candidates have now been considered under UR vacancies on their own merit. The result of these candidates under the present notice is merely change of their categories as per their merit for correction of record.

Mere inclusion of name in the result notice does not confer any right upon the candidate over the post.
