**POST GRADUATE TEACHER (HISTORY) (FEMALE)
IN DIRECTORATE OF EDUCATION
UNDER POST CODE 139/2012**

The DSSSB vide Result Notice No 484 dated 15.03.2017 had declared the result of 56 candidates for the post of *Post Graduate Teacher (History) (Female)* in Directorate of Education under **Post code 139/2012**.

The candidature of Ms Neeraj Rani (26004271) was considered for selection in view of her BLED qualification; however it has been came to know that BLED qualification cannot be considered as equivalent to the BEd qualification for selection to the post of PGT. Therefore, the candidature of Ms Neeraj Rani is hereby cancelled in OBC Category under postcode 139/12.

While declaring the said Result, the candidature of Ms Sunita Kumari (26000851) was rejected in OBC category, on the ground that she had furnished the MA degree which was after cutoff date. Now, vide her representation dated 3.4.17, she has informed that the result was declared prior to cut off date i.e 15.6.12 and further informed that that she will obtain the concerned documents from the University concern to establish her claim. In view of her representation, one vacancy created by cancellation of candidature of Neeraj Rani (26004271) in OBC category, has been kept pending. The candidate (Sunita Kumari) is hereby directed to furnish the relevant documents in respect of his claim latest by 30.06.2017, failing which the Board shall not accede to his request.

Similarly, the candidature of Ms Asha (26003292) was not considered in postcode 139/12, as she was not shortlisted for postcode 139/12 in Tier-I examination result, as in the list provided her name was not mentioned as a candidate for the postcode 139/12. Now, vide her representation dated 16.3.17, she has informed that she had applied for the post of PGT (History) under postcode 139/12 vide ID No 2082701. In view of her representation, her claim is being examined from Scrutiny and IT branch, accordingly last available vacancy in OBC category has been kept pending.

The candidature of candidate having Roll number 26004211 was pending in OBC category for clarification of MA passing date. On receipt of the requisite documents, the pending candidature is hereby considered.

The candidature of candidate having Roll number 26004409 is still pending for requisite document from candidate to ascertain the date of acquiring the PG qualification by her in UR category, accordingly the candidate is hereby directed to furnish the requisite documents in e-dossier latest by 30.6.2017.

The candidature of candidature having Roll number 26000981 in OBC category has been kept pending on account of representation filed by Ms Asha(26003292). Further, two other vacancies in OBC category are still pending in view of representation filed by Ms Suman (26002788) and Ms Pinki Devi (26004187), which are being examined by concerned branches.

The selection of the above 01 candidate shall be further subject to through verification of the candidature of the candidate by the User Department. The candidature of the candidates is liable to be cancelled by the User Department, in case, candidate is found not fulfilling all the eligibility conditions of the Recruitment Rules of the posts or for any other genuine reason. The decision of the User Department/appointing authority regarding the eligibility of the candidate shall be final and binding on the candidate.

The User department shall also check the eligibility of the reservation benefit. Further User Department shall verify the genuineness of the caste certificate furnished by the candidate prior to issuing offer of appointment to the candidate. The Competent Authority of the User Department shall arrange to verify the correctness of the information/ documents as furnished in the application forms vis-à-vis the original documents. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates before finally appointing the candidate.

Mere inclusion of the name of the candidate in the result notice does not confer any right upon the candidate over the post unless the appointing authority is satisfied after such inquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the post.
