POST GRADUATE TEACHER (HISTORY) (MALE) IN DIRECTORATE OF EDUCATION UNDER POST CODE 138/2012

The DSSSB vide Result Notice No 483 dated 15.03.2017 had declared the result of 57 candidates for the post of *Post Graduate Teacher (History) (Male)* in Directorate of Education under **Post code 138/2012**.

While declaring the said Result, candidature of Sh Hemant Kumar having Roll number 26003658 who had scored 149 marks in Tier-II examination, was considered as Not eligible in SC category in post code 138/12 on the grounds that he had done MA after cutoff date. Now he has requested the Board vide his representation dated 28.3.17 for reconsidering his candidature in postcode 138/12, in view of his submission that he had passed MA in the year 2012. However, he had not furnished any related documents to elucidate his claim that he had acquired his post graduation prior to cut off date for the post. Therefore, the candidate (Hemant Kumar) is hereby directed to furnish the relevant documents in respect of his claim latest by 30.06.2017, failing which the Board shall not accede to his request. In view of the above, the candidature of last selected candidate in SC Category (Rajesh Gautam having Roll number 26000519) is withheld till further orders.

The candidature of candidate having Roll number 26002118 was kept pending for want of his OBC certificate in OBC Category. On receipt of the requisite documents, the pending candidature is hereby considered.

In view of above and on the basis of the merit list of Tier- II examination and after preliminary scrutiny of the candidatures as per the provisions of the statutory Recruitment Rules of the post and the terms and conditions of the advertisement, the following candidates are provisionally selected to the post of PGT (*History*) male under **Post code 138/2012:**

The candidature of candidates having Roll number 26000823, 26000143 and 26004177 are still kept pending for want of all requisite documents from candidates in UR Category, these candidate are hereby directed to furnish the documents in e-dossier latest by 30.6.2017.

One vacancy is still kept pending in UR category due to ongoing court cases OA no 2234/15.

The selection of the above 01 candidate shall be further subject to through verification of the candidature of the candidate by the User Department. The candidature of the candidates is liable to be cancelled by the User Department, in case, candidate is found not fulfilling all the eligibility conditions of the Recruitment Rules of the posts or for any other genuine reason. The decision of the User Department/appointing authority regarding the eligibility of the candidate shall be final and binding on the candidate.

The User department shall also check the eligibility of the reservation benefit. Further User Department shall verify the genuineness of the caste certificate furnished by the candidate prior to issuing offer of appointment to the candidate. The Competent Authority of the User Department shall arrange to verify the correctness of the information/ documents as furnished in the application forms vis-à-vis the original documents. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates before finally appointing the candidate.

Mere inclusion of the name of the candidate in the result notice does not confer any right upon the candidate over the post unless the appointing authority is satisfied after such inquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the post.
