**TGT (URDU) IN DIRECTORATE OF EDUCATION
UNDER POST CODE 15/2010**

The DSSSB vide its advertisement No 01/2010 with closing date 15/03/2010, had advertised 30 vacancies (UR-22, OBC-01, SC-05, ST-02) for the post of TGT(Urdu) in Directorate of Education under **Post code 15/2010** in the pay scale of Rs. 5500-9000/ (Pre-revised). The Board Vide Result Notice No 244 dated 05.3.2014, Result Notice No 259 dated 14.07.2014, Result Notice No 272 dated 19.09.2014 and Result Notice number 295 dated 18.02.2015 had provisionally selected 21 candidates (UR-20, OBC-01) for the post of TGT(Urdu).

The candidature of Sh Faiyaz Ahmed, having Roll number 01510001 was cancelled vide Result Notice no 272 dated 18.09.2014 being not found eligible for post as per RR, as he had studied Urdu Subject only in two year of his graduation. Now, he has represented the Board vide OA no 1248/2015 titled Faiyaz Ahmad vs DSSSB claiming that his qualification was similar to that of the selected candidate Sh Faizan Shahid (Roll number 0150048) who was selected to the post of TGT(Urdu) vide Result 244 dated 05.03.2014, and his candidature need to be reconsidered.

In view of the judgement of the Hon'ble High Court dated 07.08.2013 in the WPC No 4483/2012 and related cases in the matter of GNCTD & Ors Vs Sachin Gupta and four petitioners, the candidature of Sh Faiyaz Ahmed have been reconsidered and on the basis of the marks scored by the candidates in the examination held on 12.05.2012 and after preliminary scrutiny of eligibility for the post as per the provisions of the statutory Recruitment Rules and the terms and conditions of the advertisement, Sh Faiyaz Ahmed is provisionally selected to the post of TGT(Urdu) in Directorate of Education under **Post code 15/2010**, whose details is as under:

Further, the candidature of candidate having Roll number 01510165 is still pending in UR category for want of document from the candidate. In view of above selection, the pending candidature of candidate having Roll number 01510149 in UR category has been kept at Waitlist candidate.

The selection of the above 01 Candidate shall be further subject to through verification of the candidature of the candidates by the User Department. The candidature of the candidates is liable to be cancelled by the User Department, in case, candidate is found not fulfilling all the eligibility conditions of the Recruitment Rules of the posts or for any other genuine reason. The decision of the User Department/appointing authority regarding the eligibility of the candidate shall be final and binding on the candidate.

The candidates who have availed the benefit of the reservation at the time of shortlisting of candidates on the basis of Tier I written examination have been considered for final appointment in their respective category only. The User department shall also check the eligibility of the reservation benefit, if any. Further, if applicable, User Department shall verify the genuineness of the caste certificate furnished by the candidate prior to issuing offer of appointment to the candidates. The Competent Authority of the User Department shall arrange to verify the correctness of the information/documents as furnished in the application forms vis-à-vis the original documents. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates before finally appointing the candidate.

Mere inclusion of the name of the candidate in the result notice does not confer any right upon the candidate over the post unless the appointing authority is satisfied after such inquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the post.

While every care has been taken in preparing the result, DSSSB reserves the right to rectify errors and omissions, if any detected at any stage.
