Mere inclusion of name in the result notice does not confer any right upon the candidates over the post.

Praveen, Roll No. 00326371 and (vi) Sh. Vinay Kumar, Roll No. 00332756. The user department shall given the said 06 candidates appointment only after verification of their genuineness.

The user department shall also get the OBC certificate verified from the issuing authority before his appointment. Further, it may also be verified that the candidate does not belong to the persons/section (creamy layer) mentioned in column 3 of the Schedule to the Govt. Of India, Department of Personnel and Training O.M.No.36012/22/93-Estt.(SCT) dated 08-09-1993, O.M. No. 36033/3/2004-Estt.(Res) dated 09-03-2004 and O.M. No.36033/3/2004-Estt.(Res) dated 14-10-2008.
