Further, if applicable, User Department shall verify the genuineness of the caste certificate furnished by the candidate prior to issuing offer of appointment to the candidates. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates and essential qualification regarding successful completion of training for the post before finally appointing the candidate.
