The DSSSB conducted combined Part-II (Descriptive Main) examination, later the Physical Endurance Test of the shortlisted candidates were conducted on 25.02.2010, the final result was declared vide Result Notice No. 81 dated 26.02.2010, whereby Board had nominated 24 candidates under post code 14/08 for the post of Matron (*Female*).

The candidature of Ms Renu having Roll number 01410307 was cancelled in OBC (Category) as the OBC certificate furnished by her was after cut off date. In view of the contempt petition before the Hon'ble Supreme Court in CP no 740/2017 in CA No 1692/2016 and judgment dated 24.02.2016 in Civil Appeal No 1691 of 2016 arising out of SLP No 27550 of 2012 in the matter of Ram Kumar Girjoya, her candidature is hereby reconsidered.

On the basis of the merit list of written examination and consequent upon qualifying the PET and after preliminary scrutiny of eligibility for the post as per provisions of the statutory Recruitment Rules and the terms and conditions of the advertisement, the candidate whose detail is mentioned below, is hereby provisionally selected to the post of Matron (*Female*) in Office of the Director General of Prisons under Postcode 14/08 in the pay scale of Rs 3050-4590/ (Pre-revised):

The selection of the above 01 Candidate shall be further subject to through verification of the candidature of the candidates by the User Department. The candidature of the candidates is liable to be cancelled by the User Department, in case, candidate is found not fulfilling all the eligibility conditions of the Recruitment Rules of the posts or for any other genuine

reason. The decision of the User Department/appointing authority regarding the eligibility of the candidate shall be final and binding on the candidate.

The candidates who have availed the benefit of the reservation at the time of shortlisting of candidates on the basis of Tier I written examination have been considered for final appointment in their respective category only. The User department shall also check the eligibility of the reservation benefit, if any. Further, if applicable, User Department shall verify the genuineness of the caste certificate furnished by the candidate prior to issuing offer of appointment to the candidates. The Competent Authority of the User Department shall arrange to verify the correctness of the information/documents as furnished in the application forms vis-à-vis the original documents. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates before finally appointing the candidate.

Mere inclusion of the name of the candidate in the result notice does not confer any right upon the candidate over the post unless the appointing authority is satisfied after such inquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the post.

While every care has been taken in preparing the result, DSSSB reserves the right to rectify errors and omissions, if any detected at any stage.
