**Subject:- Declaration of revised Marks of offline examination held on 16/09/2018 for the Post of Physical Education Teacher, Post Code-90/17 and uploading e-dossier – regarding.**

In compliance of the directions of the Hon'ble CAT in lead O.A. No. 580/2019 titled as Harish Kumar & Ors Vs. DSSSB & Ors. and in various OAs linked therewith the marks for the post of Physical Education Teacher, Post Code-90/17 have been revised as number of candidates had approached the Hon'ble CAT. Subsequently, the OAs filed by the candidates have been disposed of by the Hon'ble CAT vide order dated 14/03/2019 in lead matter of O. A. No. 580/2019. While disposing these OAs vide aforesaid orders dated 14<sup>th</sup> March, 2019, the court gave the following directions:-

".....11. Having regard to the facts and circumstances of the cases, we dispose of these O.As. by directing that:

*a) the respondents shall take immediate steps to refer the answers in the final key in respect of question Nos. 44, 119, 182, 183 & 200, for the examination conducted for selection to the post of Physical Education Teacher with Post Code No.90/17 to experts forthwith, with a specific direction that a report or opinion in this behalf shall be furnished, within one week,*

*b) further steps in the process of selection shall be taken soon after the opinion is obtained, as indicated above.*



**c) under no circumstances, the steps indicated in this order shall be treated or construed as an impediment for implementation of the directions issued by the High Court**

Accordingly, in compliance of the above directions, the questions referred above were placed before the Committee of experts and as per the recommendations of the Committee, 04 questions have been deleted and evaluation has been done again after deleting these questions.

Therefore, in supersession of previous notice No. 187/Physical Education Teacher/Int. Cell/Result/ DSSSB/2018-19/ 545 dated 15.02.2019, the marks of all the candidates for the post of Physical Education Teacher Post Code-90/17 have been revised and uploaded in the candidates account in OARS module. All the candidates can view their marks by logging into their account in OARS module on [www.dsssonline.nic.in](http://www.dsssonline.nic.in)

Further, the candidates who are above the minimum qualifying marks have been shortlisted. All such candidates are now required to upload their documents like Educational/Professional Certificates/ Degree and Mark sheets/Caste Certificate/Disability certificate/Proof of Govt. Servant/Ex. Servicemen/ Admit Cards etc., as required in the E-dossier module in OARS link in their individual account in OARS module.

The category wise cutoff marks (revised) for uploading e-dossier have been given as under:-

The link for uploading e-dossier shall be kept open for a period of 10 days w.e.f. **27/04/2019 to 06/05/2019**. All the shortlisted candidates are required to upload their e-dossier in the above given time period.

The shortlisted candidates uploading e-dossier should ensure that they fulfill all the eligibility criteria as on the cutoff date, i.e **31/01/2018**. The shortlisted candidates are also being separately informed through SMS & E-Mail on their registered mobile number & e-mail id. **If, any candidate fails to upload the e-dossier during the above said period, his/her candidature will be rejected and no further opportunity for uploading e-dossier will be given on whatsoever ground.**

**Mere uploading of documents in the e-dossier module does not confer him/her any right to selection to the applied post.** Final selection will be made purely on the basis of merit against the notified vacancies provided the candidate falling in the zone of consideration fulfills all the required eligibility conditions. It is reiterated that if the candidate fails to upload his/her documents on or before the date as mentioned above he/she will not be given any further opportunity and his/her candidature will be treated as cancelled.
