In the above advertisements it was mentioned at 'Note' -(i) below the Annexure-I that

applicants of these post codes must qualify in Section A & B separately as per their category (UR/OBC/SC/ST/PH/ExSm) minimum qualifying marks. However, final merit will be prepared on the basis of aggregate marks of both the section A & B (pls. refer notices dated 28/7/2017 available on the website of the Board).

The matter has been examined with reference to the above said office's notice no. F.4/(100)/2012/P&P/NES/DSSSB/805-810 dated 28/07/2017 and notice no. F.4/(100)/2012/P&P/NES/DSSSB/811-816 dated 28/07/2017 (which are available on the website of the Board) and it has been observed that the said notices are only for the posts of TGT, Primary/Nursery/Assistant Teachers (where applicants have to qualify separately in both Section-A & Section-B). Accordingly, this condition is not applicable for the above mentioned posts.

Therefore, "Note" –(i) below the Annexure-I of the Advertisement No. 04/2017 may be read as 88/17 to 89/17, 131/17 to 147/17 instead of 87/17 to 92/17, 131/17 to 147/17. Rest of the contents shall remain unchanged.

Further, "Note" - (i) below the Annexure-I of the Advertisement No. 02/2017 may be read as **16/17** instead of 15/17 to 22/17, 61/17 to 77/17 & 80/17. Rest of the contents shall remain unchanged.

The vacancy notice for the post codes 17/17- 22/17, 61/17-77/17 & 80/17 had already been cancelled vide notice no. F1(351)/DSSSB/P&P/2017/Advt/884-889 dated 24/08/2017 which is available on the website of the Board.
