RESULT NOTICE NO: 414

PGT (POLITICAL SCIENCE) FEMALE, POST CODE-115/17 IN DIRECTORATE OF EDUCATION.

The DSSSB vide its advertisement No. 04/2017 dated 22/12/2017 had advertised total 115 {UR-54, OBC-34, SC-16, ST-11 including PH (VH-01)} for the post of PGT (POLITICAL SCIENCE) FEMALE, POST CODE-115/17 in Directorate of Education with closing date as 31.01.2018. Tier-I examination in offline written examination mode was conducted on 12/08/2018.

- 2. All 6541 candidates who had appeared in written examination were informed through notice No. F. No. 189/PGT (Political Science)/Female/Int. Cell/Result/DSSSB/2018-19/564 dated 18/02/2019 on the Board's website i.e. www.dsssbonline.nic.in that their marks for the examination dated 12.08.2018 for the post of PGT (Political Science) Female Post Code-115/17 have been declared and the same were available in their account in OARS module. Further, vide said notice, 249 shortlisted candidates were given the opportunity to upload their documents in the e-dossier module w.e.f. 25.02.2019 to 06.03.2019 with the specific direction that if any candidate fails to upload the e-dossier during the above said period, his/her candidature will be rejected and no further opportunity for uploading e-dossier will be given on whatsoever ground. In all, a total of 238 candidates uploaded their documents in the e-dossier portal and 11 candidates failed to upload their documents in the e-dossier.
- 3. On the basis of marks secured in the written examination and after preliminary scrutiny as per the provisions of the statutory Recruitment Rules for the post and the terms and condition of the advertisement, the following candidates are provisionally nominated, as per their merit, to the post of PGT (Political Science) Female, Post Code-115/17 in Directorate of Education subject to their fulfilling all other conditions of eligibility as also correctness of the information furnished by the candidates in their online application form and e-dossier:-

- 4. The candidates mentioned at SI. No. 21, 24 & 43 under UR Category possessing Master Degree in Public Admn./ M.A. Politics (International Relations) instead of Master Degree in Political Science. However, as the subjects of Public Administrations/politics are parts of Political Science and seem to be equivalent qualification to M.A. (Political Science), the candidates having degree of M.A. (Public Administration) & M.A. Politics (International Relations) are being provisionally nominated subject to satisfaction of the user department regarding their eligibility before issuance of their appointment.
- 5. The selection of the above candidates shall further be subject to genuineness of the documents on the basis of which they have claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of advertisement inviting applications and subject to thorough verification

of their identity with reference to their photographs, signatures/handwriting etc. on the application form, admission certificate etc. The candidature of the above candidates are liable to be cancelled by the User Department also, in case the candidates are found not to be fulfilling the terms & conditions of the advertisement inviting applications for the said post code. The decision of the User Department regarding the eligibility of the candidate shall be final and binding on the candidate.

- 6. The user department shall also check the eligibility of the reservation benefit, if any. Further, if applicable, User Department shall verify the genuineness of the Caste Certificates furnished by the candidates prior to issuing offer of appointment to the candidates.
- 7. The User Department shall also get the SC/ST/OBC certificates verified from the Issuing authority. Further, if applicable User Department shall verify the genuineness of the Caste Certificate furnished by the candidate prior to issuing offer of appointment to the candidate. In case of the OBC candidates, it may also be verified that the candidate does not belong to creamy layer of the schedule of Govt. of India, DoPT O.M. No. 36012/22/93-Estt. (SCT) dated 08.09.1993, O.M. No. 36033/3/2004-Estt. (Res) dated 09.03.2004 and 14.10.2009 and O.M. No. 36033/1/2013-Estt. (Res) dated 27.05.2013.
- 8. The Competent Authority of the Department concerned shall issue the appointment letters to the candidates after being satisfied about his eligibility as laid down in the recruitment rules and after verification of the correctness of the information/documents as furnished in the application form and edossier vis-à-vis the original documents related to Educational Qualification, Age and other essential Certificates as per instructions issued by Govt. of India in this regard vide MHA O.M. No. 2/29/54-RPS, 19-11-54.
- 9. The user department shall ensure that the appointment made is in conformity with DoPT guidelines and instructions of Govt. issued from time to time.
