**Fireman (Band) under post code 56/15, in Delhi Fire Service.**

The DSSSB vide its advertisement No. 01/2015 with closing date 26/11/2015, had advertised 26 vacancies [(UR-13, OBC-07, SC-04 & ST-02 including EXSM 03)] for the post of Fireman (Band) in Delhi Fire Service. The Board had conducted One Tier written examination for recruitment to this post on 14.05.2017.

Further, vide notice No. 645 dated 15.05.2018 based on the performance in One Tier written examination, 37 (Thirty seven) candidates (UR-24, OBC-05, SC-06, & UREXSM) were provisionally shortlisted to appear in the Physical Endurance Test subject to attaining minimum qualifying marks and correctness of the information furnished by the candidates in their online application forms. The physical endurance test was conducted on 18/09/2018 in which 25 candidates appeared for Physical endurance test.

As per prescribed Performa provided by user department i.e.DFS. Final merit list shall be prepared based on total marks obtained out of 200 (i.e. 100 marks each for Physical Endurance Test & Written Test). It has also been specifically mentioned in the above proforma that "a candidate will have to qualify in all of the three events individually with minimum 33% marks to declared pass".
