**SUPPLEMENTARY RESULT NOTICE NO: 924 Dated 27/02/2024**

**ASSISTANT TEACHER PRIMARY, POST CODE - 47/21 IN**  
**NEW DELHI MUNICIPAL COUNCIL**

1. The DSSSB vide its advertisement No. **02/21** dated **12/05/2021** had advertised **120** vacancies [ EWS-35, UR-45, OBC-17, SC-16, ST-07, ( Including PwD: OH:-01, VH-02, HH-02)] for the post of ASSISTANT TEACHER (PRIMARY) under post code 47/21 in New Delhi Municipal Council and conducted Tear-I examination (Online mode) for recruitment on 23.03.2022, 24.03.2022, 25.03.2022 and 26.03.2022.
2. On the basis of marks secured in the written examination for the post of **Assistant Teacher (Primary), Post Code - 47/21** and the terms and condition of the advertisement 02/21, total 120 candidates under [( EWS-35, UR-45, OBC-17, SC-16, ST-07, (Including PwD: OH:-01, VH-02, HH-02)] Category were provisionally nominated and 29 candidates ( EWS-07, UR 09, OBC-04, SC-04, ST-02, (PwD: VH-01, OH-01, HH-01) in waiting panel were provisionally nominated for the post of **Assistant Teacher (Primary), Post Code-47/21 in NDMC, vide Result Notice No. 893 dated 30/08/2022.**
3. Further, the User Department i.e. NDMC has returned 40 dossiers of candidates after cancellation of their candidature who failed to join their duties in the User Department vide letter dated 29.05.2023, 02.08.2023 & 24.08.2023. The user department has further requested to provide 40 candidates (UR-19, EWS-09, OBC-06, SC-06) from the waiting panel. The waiting panel for the post code-47/21 was valid for a period of one year from the date of declaration of Main Result i.e. upto 29/08/2023 and the requisition for substitute candidates received before expiry of waiting panel. Furthermore, while providing substitute candidates in Supplementary Result, 05 candidates (04- OBC, 01- SC) have been shifted from their respective category to UR category as per own merit candidate. Accordingly, 45 candidates (UR-19, EWS-09, OBC-10, SC-07) from waiting/reserve panel have been provisionally nominated for the post of **Assistant Teacher (Primary), Post Code-47/21 in NDMC.**
4. The Board has not undertaken any scrutiny of documents uploaded in the e-dossier at this stage as per Board's resolution/decision dated **14/07/2022**. The eligibility as per Recruitment Rules and other terms and conditions as specified in the Advertisement No. 02/21 and relaxations as per rules in respect of educational qualifications, age, experience, etc. shall be scrutinized / verified by the User Department for determining eligibility of the candidates for the post code- 47/21 as on cutoff date 24/06/2021 before issuance of offer of appointment to the post.



5. Accordingly, in continuation of Result Notice No. 893 dated 30/08/2022, the candidates, as detailed below, are also provisionally nominated purely on the basis of marks obtained by the candidate in the basis of online examination of Tier-1 held on 23/03/2022, 24/03/2022, 25/03/2022 & 26/03/2022 and also claims made by the candidate in their online application forms for the post of **Assistant Teacher (Primary), Post Code-47/21 in NDMC :-**

- The candidate bearing Roll No. 111504700323 mentioned at SI No. 3 above was provisionally nominated under SC category vide Main Result Notice No. 893 dated 30/08/2022. Now, his/her candidature is in consideration zone under UR category as per own merit candidate. Further, 04 candidates bearing Roll No. 112304701694, 111604701513, 111604702648 & 112904700995 mentioned at SI No. 10, 12, 13 & 19 above were provisionally nominated at Main Result Notice No. 893 dated 30/08/2022 under OBC category. Now, their candidature is also in consideration zone of UR category as per own merit candidate. Now, the above 05 candidates have been provisionally nominated under UR category. The User Department may modify their result as per policy/guidelines of DoPT & in accordance with Services Department circular dated 02/08/2021.

6. The provisional nomination of the above **45 candidates (UR-19, EWS-09, OBC-10, SC-07)** is on the basis their claims in their application shall be subject to through





verification of their candidature by the user department including the identity of the candidates as per Services Department circular No. F16(3)/2007/S-III/1756-1763 dated 02/08/2021.

7. The provisional nomination of the above **45 candidates (UR-19, EWS-09, OBC-10, SC-07)** shall further be subject to genuineness of the documents on the basis of which they have claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of advertisement inviting applications and subject to thorough verification of their identity with reference to their photographs, signatures/handwriting etc. on the application form, admission certificate etc. The candidature of the above candidates are liable to be cancelled by the User Department also, in case the candidates are found not to be fulfilling the terms & conditions of the advertisement inviting applications for the said post code. The Competent Authority of the Department concerned shall issue the appointment letters to the candidates after being satisfied about their eligibility as laid down in the recruitment rules and after verification of the correctness of the information furnished in the application form and the documents related to Educational Qualification, Age and other essential certificates.

8. The user department shall also check the eligibility of the reservation benefit, if any. Further, if applicable, the User Department shall verify the genuineness of the Caste Certificates furnished by the candidate prior to issuing offer of appointment to the candidate. The Competent Authority of the user department shall arrange to verify the correctness of the information/documents as furnished in the e-dossier vis-à-vis the original documents. User Department is requested to ascertain the scrutiny /correctness of the same at their own level before issuing the offer of appointment to the provisionally selected candidates. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates and essential qualification for the post before finally appointing the candidate. The User Department is also requested to rectify/correct, in case, any minor/clerical error/deficiency noticed in the documents of the candidate at their own level.

9. It is stated that the User Department shall verify the genuineness of the caste certificate furnished by the candidate in the light of Notification No. 36012/22-93-Estt. (SCT) dated 08/09/1993 issued by DOPT and other instructions/guidelines issued from time to time by the Competent Authority prior to issuance of offer of appointment to the candidate. It is further stated that, prior to appointment, the User Department must satisfy, itself, that the above candidate is fulfilling the necessary criteria as prescribed for entitlement of OBC (Delhi) certificate as specified in various Orders/Guidelines/Circulars including order dated 07/03/2017 issued by Revenue Department, GNCTD after thorough verification of caste certificate.



10. The User Department shall also get the SC/ST/OBC/PH/ExSM/etc. certificates verified from the Issuing authority. Further, if applicable, User Department shall also verify the genuineness of the caste certificates furnished by the candidates prior to issuing offer of appointment to the candidates. In case of the OBC candidates, it may also be verified that the candidate does not belong to creamy layer of the schedule of Govt. of India, DoPT O.M. No. 36012/22/93-Estt. (SCT) dated 08.09.1993, O.M. No. 36033/3/2004-Estt. (Res) dated 09.03.2004 and 14.10.2009 and O.M. No. 36033/1/2013-Estt. (Res) dated 27.05.2013 & 13.09.2017.

11. The User Department shall also get the EWS certificates verified from the Issuing authority. Further, the User Department shall also verify the veracity of the Income and asset certificate submitted by the candidate through the certificate issuing authority as per instruction of DoPT O.M. No. 36039/1/2019-Estt (Res) dated 31.01.2019.

12. The Competent Authority of the Department concerned shall issue the appointment letters to the candidates after being satisfied about his eligibility as laid down in the recruitment rules and after verification of the correctness of the information/documents as furnished in the application form and e-dossier vis-à-vis the original documents related to Educational Qualification, Age and other essential Certificates as per instructions issued by Govt. of India in this regard vide MHA O.M. No. 2/29/54-RPS, 19-11-54.

13. The user department shall ensure that the appointment made is in conformity with DoPT guidelines and instructions of Govt. issued from time to time.

14. The category wise marks obtained by the last selected candidate has been given as under:-


15. The result process for the above post code stands closed in all respect.
