## POST GRADUATE TEACHER (HOME SCIENCE) (FEMALE) IN DIRECTORATE OF EDUCATION UNDER POST CODE 188/2014

- 1. The DSSSB vide result Notice no 453 dated 11.11.16 had declared the result of 02 candidates for the post of *Post Graduate Teacher (Home Science)* (female) in Directorate of Education under **Post code 188/2014**.
- 2. The candidature of the candidates having Roll number -23001155, 23001153, 23001050 in UR category; 23000862 in OBC category and 23000214 in SC Category were kept pending for seeking clarification from the User Department regarding nomenclature of their Master's Degree/Essential Qualification. The User Department was requested vide letter dated 03.08.2016, and its reminder dated 10.11.2016, 14.07.2017, 12.10.2017, 10.11.2017, 14.12.2017, DO letter dated 09.04.2018 and 01.10.2018. However the requisite clarification was not provided by them.
- 3. In the meantime some applicant (total 09) of the postcode 140/12 and 188/14 whose candidature was kept pending approached the Ld CAT for seeking relief for declaration of their result. Ld. CAT in OA No. 1927/2018 & MA no 2177/2018 in the matter of Pooja Akshay & Anrs vs GNCTD & Ors vide order dated 09/10/2018 has given the direction to declare the result, accordingly the pending result is hereby processed.
- 4. Earlier one vacancy was kept withheld in view of court case filed by Anshu Saini vide OA no. 2233/2015 in the matter of Ms Anshu Saini v/s GNCTD. As Ld CAT vide order dated 21.03.2018 has dismissed the said OA, the withheld vacancy is hereby released.
- 5. The candidature of candidate having roll number 23001170 was earlier pending in postcode 140/12 as her candidature has been rejected in postcode 140/12 being not qualified as on cut off date in postcode 140/12, as such her candidature is hereby considered in UR category in postcode 188/14 as per merit. In view of consideration of candidature of candidate having roll number 23001170 in postcode 188/14, the candidate having roll number 23001050 shall not be in the zone of selection.

- 6. The candidate Ms. Lakshmi Balyan (23001104) has applied for postcode 140/12 and 188/14 for the post of PGT (Home Science). The candidate was shortlisted under UR category for Tier-II exam in both postcodes 140/12 and 180/14. As per the online application form the applicant has applied as UR category in post code 140/12 and as OBC category in postcode 188/14. Accordingly the candidature of candidate having roll number 23001104 is hereby considered in OBC category in postcode 188/14.
- 7. In view of the above and on the basis of the merit list of Tier-II examination and after preliminary scrutiny of the candidatures as per the provisions of the statutory Recruitment Rules of the post and the terms and conditions of the advertisement, the following candidates are provisionally selected to the post of PGT (Home Science) Female under Post code 188/2014 subject to satisfaction of eligibility of their candidature in reference to the qualification mentioned against each:

- 11. The meritorious candidates who have already been selected for the post of Post Graduate Teacher (Home Science) Female under post code 140/2012, have not been considered for this post, as the DSSSB has conducted the combined examination for the post of 140/2012 and 188/2014.
- 12. The selection of the above 06 candidates is purely provisional <u>subject</u> to satisfaction of eligibility of their candidature in reference to the <u>qualification mentioned against each and</u> further subject to thorough verification of the candidature of the candidate by the User Department. The candidature of the candidates is liable to be cancelled by the User Department, in case, candidate is found not fulfilling all the eligibility conditions of the Recruitment Rules of the posts or for any other genuine reason. The decision of the User Department/appointing authority regarding the eligibility of the candidate shall be final and binding on the candidate.
- 13. The candidates who have availed the benefit of the reservation at the time of shortlisting of candidates on the basis of Tier I written examination have been considered for final appointment in their respective category only. The User department shall also check the eligibility of the reservation benefit, if any. Further, if applicable, User Department shall verify the genuineness of the caste certificate furnished by the candidate prior to issuing offer of appointment to the candidates. The Competent Authority of the User Department shall arrange to verify the correctness of the information/ documents as furnished in the application forms vis-à-vis the original documents. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates before finally appointing the candidates.
- 14. Mere inclusion of the name of the candidate in the result notice does not confer any right upon the candidate over the post unless the appointing authority is satisfied after such inquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the post.
- 15. While every care has been taken in preparing the result, DSSSB reserves the right to rectify errors and omissions, if any detected at any stage.
